

<p>MO; By entering home by breaking a small window on rear entry door, reaching through window, unlocking door deadbolt to gain entry, and removing copper pipe from basement without owners permission.</p> <p>On 1-29-08 at 1015 hrs., INV. WALLING and I were detailed to 1250 Chase on the report of a Breaking and Entering offense. On arrival, INV. WALLING and I spoke with VIC/COLLETA GRAHAM. GRAHAM advised officers that she checked on her vacant property this morning and noticed her front door unlocked. GRAHAM said she entered the home, she noticed the rear entry door had a window pane broken out and the door was unlocked. GRAHAM checked the home, she said nobody was inside but thinks some of her basement copper plumbing was stolen.</p> <p>We double checked the home to make sure nobody was inside. In checking the basement, we noticed that most of the copper plumbing was removed from the basement. However, the copper pipe that goes to the first and second floor was still intact and nothing was pulled through the walls.</p> <p>Nothing else was damaged or stolen from the home.</p> <p>GRAHAM has no suspect(s).</p> <p>See INV. WALLING's report for further details.</p> <p>I checked with the neighbor at 1254 Chase, KATHY BURKETT, who said she did not see or hear anything (1 south). I knocked at 1246 Chase, nobody was home at this address.</p>
