Topic Original Report

MO: By putting what victim believed to be gun in victims chest and hip and taking victims property without permission and leaving with same.

On 1/20/08, at 2001 hrs., officers were detailed to the area of Detroit and Gladys on a complaint from VIC/RONALD BROADBENT stating he was robbed by gunpoint. On arrival I spoke with BROADBENT and WIT/ and they advised the following. BROADBENT and were walking N/B on Gladys after they went to Burger King. noticed two males were following them.

and BROADBENT walked through the Municipal Parking lot E/B to Cook. BROADBENT advised, as they got to Cook he turned and observed the two males running towards him. The male wearing a blue coat later identified as ARJ/ stuck a gun in BROADBENT'S chest. The other male wearing a white hooded sweatshirt later identified as ARJ/ stuck gun on BROADBENT'S hip. told BROADBENT to give him the bag of Burger King he was carrying. BROADBENT complied, and stated both and ran west through the Municipal parking lot and N/B on Cook. stated at the time and approached BROADBENT he was about five feet in front of BROADBENT. advised he turned around and observed and holding guns on BROADBENT.

The description of the suspects were given out over the radio. A short time later PTL. BROWN observed the suspects running W/B on the tracks from Virginia towards Lakeland. PTL. LEANZA advised he had ARJ/ in custody at 1271 Summit. PTL. LEANZA further advised, had a plastic gun in his waist band.

A short time later PTL. MOLNAR advised, he had the second suspect ARJ/ in custody at 1287 Summit. advised he "ditched the gun". and PTL. MOLNAR walked to 1299 Lakeland and pointed out where the gun was. INV. REGISTER took photos of both guns.

I brought BROADBENT and to Summit and they both positively identified and BROADBENT advised he does desire prosecution. and were transported to LPD and booked in by CO BUNNER. BROADBENT and both gave written statements and were driven home by this officer. BROADBENT and parents were made aware of the incident.

The guns and the suspects clothing were tagged as evidence and placed in the property room.
