Topic Original Report

M.O.: By holding a metal object in his hand, and demanding the victim to give him everything in his pockets.

On 1-30-08 at approximately 0303 hrs, I responded to 14512 Madison regarding a male that was robbed at approximately 0200 hrs. When I arrived on scene I spoke with VIC/JEREMIAH ROPUE and learned the following:

ROPUE stated he was walking his girlfriend, OIV/ADRIENNE FIENING, home from The Lakewood Tavern, 13437 Madison, at approximately 0205 hrs. ROPUE stated they crossed to the north side of the street and began walking westbound. After walking about a block or so a Hispanic male approached him. ROPUE indicated the male was holding a metal object in his hand that resembled an old police baton. The male demanded ROPUE to give him everything that was in his pockets. ROPUE indicated he told the male he did not have anything, and his girlfriend waved the male off and began to continue walking westbound. ROPUE indicated FIENING was intoxicated and believes she did not realize what was going on. ROPUE stated the male continued to follow them west for another block and demanded everything from ROPUE again. ROPUE indicated he gave his wallet to the male at this time. ROPUE stated the male then turned and ran away eastbound.

ROPUE described the male as being Hispanic, approximately 5'6 to 5'8 with a skinny build, approximately 130 to 160 lbs, dark brown or black short hair, possibly a goatee, and in his early 20's. The male was wearing a jacket with a cow print pattern, white with black spots. The male was wearing a dark color hooded fleece underneath the coat, and had the hood pulled up over his head.

ROPUE believes he may recognize the male if he saw him again and is unsure about prosecution due to the fact he lives out of state. ROPUE indicated he did not contact the police right away because he did not think he had enough information to provide on the suspect. He was advised on solvability.

ROPUE's wallet contained his Illinois drivers license, one debit card and one credit card. The wallet also contained a prepaid credit card which contained approximately \$10, and a pay stub. The pay stub contained ROPUE's social security number.
