1	<p>MO/ By knowingly having in his possession an instrument commonly used to ingest narcotics To Wit: 1-brown wooden pipe with burnt residue.</p> <p>On 01-31-08 while on patrol southbound on W.117th at Detroit I observed the listed vehicle also southbound on W.117th. The vehicle was paced at 40mph in a 25mph zone. The vehicle was stopped and the driver was identified as the owner of the vehicle (OWN) NEER, VICTORIA. NEER was advised for the reason of the stop.</p> <p>NEER stated that she had responded to Lakewood to pick-up the two passengers in the vehicle identified as (ARA) ROHFELD, WILLIAM and (SUB)PHELPS, JAMES. Both had been drinking in Lakewood and called NEER for a ride home. In checking the parties through the computer PHELPS was found to have an active warrant from (GOV) LORAIN COUNTY SHERRIFFS, for neglect child.</p> <p>While speaking with PHELPS who was the back seat passenger, ROHFELD was observed reaching around the front seat area and underneath the front seat. The warrant for PHELPS was confirmed at 0314hrs by SANCHEZ of Lorain County SO. PHELPS was then handcuffed, searched and secured in car 216.</p> <p>I then had ROHFELD exit the vehicle, he was asked if he had any contraband on his person. ROHFELD was also asked why he was reaching underneath the front seat. ROHFELD stated that he did not have any contraband on his person. ROHFELD added that he was attempting to find paperwork for NEER's vehicle when he was reaching around the front seat. ROHFELD was asked if I could search his person and he consented.</p> <p>In ROHFELD's right front pocket I located the listed marijuana pipe. ROHFELD was then issued citation M38843 for Drug Paraphernalia. ROHFELD was released at the scene. NEER was advised on the traffic violation and released at the scene.</p> <p>P.O. GREEAR and I then transported PHELPS to I-90 and Crocker-Bassett Rd. . PHELPS was turned over to Lorain County SO car #359. The marijuana pipe was taken to the station where it was tagged and placed in the chute located in LPD's secured property room.</p>
