N A R R A T I V E 1	Topic	Original Report
	M.O. By entering unoccupied residence through a rear window and taking \$800 worth of copper piping from the basement.	
	On 2-1-08 at 1443hrs I was detailed to 1336 Bonnieview on the report of copper stolen from the residence. Upon arrival I spoke with VIC/JONATHAN GRAY by phone and he stated the following.	
	GRAY, who is currently selling the house, was notified on 1-31-08 that copper was missing from the basement. GRAY stated a bank appraiser was looking at the house and noticed the copper missing. GRAY said he had a real estate agent look through the house on 1-24-08 and the copper was still there. This was the last time the copper was seen.	
	GRAY, who currently resides in Arizona, stated the house was locked when the appraiser went through it yesterday, but a rear window on the west side of the house was ajar. This was the probable point of entry and exit. The window would only have been seen from rear adjacent yards. SUS(S) entered the residence and removed copper pipes from different parts of the basement.	
GRAY said the house is changing ownership next week and he is not going through his insurance company, only the bank. GRAY has no suspects and prosecution is desired if an arrest is made.		
GRAY had a plumber open the house to put in new piping. INV.KULCZYCKI responded for ET work and found NOV. There was no answer to the house on the north and south side of 1336.
