Topic Original Report

MO/ By prying back window guard, and breaking door window in order to gain entry into a vacant house and removing copper piping from same without owner consent.

On 2-1-08, at 1902 hours I was detailed to 1658 Elbur on a report of copper piping stolen from the residence. On arrival I spoke with VIC/ALATRASH. She is the owner of the house at 1658 Elbur. The house is vacant and is up for sale. She came to the house to check on it on 2-1-08 around 1900 hours. She found the ceiling tiles in the basement had been torn down and copper piping had been removed from the basement. ALATRASH believes the last time anyone was at the house was on 1-26-08.

ALATRASH also noted that the front door and back door were found unlocked. She stated both doors should have been locked. She had no suspects in the incident. She desires prosecution.

It appears entry into the residence was gained through the back door. A metal grated guard covered the window on the back door. The grating had been peeled back far enough to fit a human fist through. The window behind the bent grating was cracked and could be pushed inward. The door lock was reachable from the crack in the window. ALATRASH noted that the grating being pulled back and the broken window were fresh damage.

The stairs to the basement are just inside the back door. The basement was a finished basement. The ceiling tiles throughout the majority of the basement had been ripped down. The metal rails that held the tiles in place had also been ripped down. The copper piping throughout the basement was accessible when the ceiling tiles were removed. Most of the copper piping in the ceiling had been removed. The copper piping to the hot water tank had also been removed. The pipes look as if they had been cut and pulled out. The break points in the pipe were jagged. A pipe cutter was not used to cut the pipe.

INV MLADEK responded for ET. He took photos of the scene. No latents were recovered. It should be noted that some of the stolen pipe had a hard black coating on it. INV MLADEK took photos of some of the remaining coated pipe.

ALATRASH checked the rest of the house and nothing was missing. ALATRASH had no suspects in the incident. She desires prosecution.

I canvassed the neighborhood for information. I found the 1663 and 1666 Elbur were also vacant houses. They both checked secure. No one was home, or I got no answer at 1655, 1662 and 1651 Elbur. I spoke to the residents of 1654 and 1659 Elbur and no one observed anything unusual.
