Topic Original Report

MO - #1 By using physical force, having a weapon on their person and pushing Victim inside his apartment for the purpose of committing a theft offense. #2 By trespassing in an occupied structure with the victim present and committing a theft offense. #3 By force push the victim into his apartment with purpose to committ a felony offense of Agg. Burglary. #4 By using a mask, bandana's and grocery bag to aid the commission of the theft offense. #5 By having in his possession folded paper containing suspected marijuana approx. (.13 grams). #6 By being under the age of 21 and being under the influence of alcohol. #7 By having in their possession and concealed on their person, a knife, brass knuckles and wooden martial arts baton when stopped by the police.

LT. WARNER, Sir;

On 020208 at 2226 hrs., Officers were detailed to the area of 1444 COUTANT, Apt. #202, on report of a male just robbed at gunpoint by three males; 2 white males and 1 Hispanic male. One of the males was wearing a blue jacket, blue jeans and a brown ball cap. The males left on foot in an unknown direction. I responded to the Colonial Club apartments to speak with the VICTIM/JOHN HAMMOND, who was outside of the complex speaking to PO. GAMPFER, when I arrived. The following was advised:

HAMMOND stated that he was actually robbed inside the hallway of the Colonial Club Apartments on the second floor. HAMMOND stated when he stepped out of his apartment to check his mail and then while returning was pushed from behind by a Hispanic male, later identified as, ARA/JULIO GUEITS, JR., who forced him back inside his apartment, #202, along with two white suspects males, later identified as, ARA/DERIK F. MURPHY and, ARA/JOSEPH A. HOLSTEIN. HAMMOND said JULIO told him to sit on the futon couch next to the door, then brandished a black barreled semi-automatic handgun in his right hand, pointing it at HAMMOND's right temple. JULIO told HAMMOND, "I will kill you, mother fucker, don't move, I will kill you."

HAMMOND said JOSEPH (who he said was the taller of the two white males) told JULIO to take HAMMOND into the bedroom/dining area while they ransacked the entire apartment. The males also pulled out the phone connection in the wall of the living room. HAMMOND said JULIO handed JOSEPH the handgun so he could keep HAMMOND at gunpoint.

After the ransacking took place and the males were about to leave, JULIO threaten HAMMOND, telling him not to call the Police, that he would be watching him. JULIO then threatened to kill HAMMOND if he did. All three males left the apartment on foot and cut across the parking lot w/b out of sight. HAMMOND said he advised his neighbor in apartment #204, COM/PAUL M. AGNEW, to call Police.

A more complete physical description was given out to Officers in the area checking for the suspects, as follows; Suspect #1: Hispanic male wearing a brown ball cap (\$ logo in front), royal blue jacket, blue jeans, white tennis shoes, approx. 5'-9" to 5'-10" tall, 180-190 lbs., short brown hair, brown eyes, approx. 30 years of age, and brandishing a black barreled semi-automatic handgun. Suspect #2: White male, wearing black face mask, black bandana, black hooded, black jeans, approx. 5'-9" tall, 170-180 lbs., blue eyes, approx. 17-19 years of age. Suspect #3: White male, wearing a black hooded, black jeans, blue bandana, approx. 5'-7" to 5'-8" tall, weighing approx. 150 lbs.

At approx. 2239 hrs., while still on scene with HAMMOND, Officers called out with two of the males in custody at 1519 Ridgewood. A third male had ran inside the upstairs residence and was later placed in custody at 2250 hrs. All three males matched the suspect(s) descriptions given out over the radio. I transported HAMMOND to 1519 Ridgewood and he positively identified all three males as the males who robbed him at gunpoint.

HAMMOND was transported back to his residence and gave me a two page statement and stated he wants prosecution. INV. DEUCHER arrived on scene and took photos of the apartment left in disarray by the ransacking. No prints were obtain.

INV. MLADEK filled out property tags and had HAMMOND sign for each item taken prior to it being released.

JULIO, DERIK and JOSEPH were all booked in by PO. D. MCCARTHY for AGG. ROBBERY, AGG. BURGLARY and KIDNAPPING. DERIK was also booked in for CCW, Criminal Tools, Drug Abuse & Sales to Minors. JOSEPH was also booked in for CCW and Criminal Tools.
