Topic Original Report

On 2/2/08 at 2325 hrs, Officer Leanza and I responded to 2055 Warren. Dispatch indicated Cecom's contacted us indicating there was a disturbance at the address. They were unable to provide any further information. When I arrived on scene I spoke with COM/BERTINA MAVE and OIV/JOEY PETTRY and learned the following:

MAVE stated OIV/CARLOS was at her residence regarding money that was owed to him by her son's father, OIV/JASON SWENDERS. MAVE stated CARLOS has been coming to her residence regarding this matter a lot recently and she finally told him she was tired of this and told him to leave. SWENDERS does not reside with MAVE. When MAVE told CARLOS to leave, she stated he punched her in the face and continued to strike her with his fists.

PETTRY, MAVE's boyfriend, stated MAVE and CARLOS were talking in the bedroom when he heard them begin to argue. When he heard the two begin to get physical, he ran in the bedroom to help. PETTRY indicated CARLOS was striking MAVE, so he began fighting with CARLOS to get him off of her. The fight then moved into the dining room where MAVE fell onto the floor unconscious for over a minute. PETTRY was able get CARLOS to leave the residence, and called 911. PETTRY stated CARLOS left in a blue/purple SUV, possibly a Kia or an Escape.

MAVE and PETTRY stated CARLOS sells crack/cocaine, and is afraid of CARLOS. They advised he stays in the apartments located on the corner of Madison and Mars on the south side of the street in Apt 11 when he is in town. This is where he is known to sell drugs in Lakewood. They did not state if it was the apartment building located on the east or west corner. MAVE was unable to provide any further information on CARLOS.

MAVE had a split upper lip, and had a large lump on the back left side of her head. The squad arrived to assist, but MAVE denied medical attention. MAVE indicated she wasn't sure if she desired prosecution, and stated she would call back later if she changed her mind.

After clearing the scene, MAVE was taken to the Lakewood ER by a family member. Inv. Mladek arrived on scene to take photo's. While Inv. Mladek was on scene, MAVE indicated she desired prosecution.

Let it be known on 1/23/08 CPD Detective Gray contacted our department regarding a male they had arrested during a drug deal. The male was in a vehicle registered to a female, MAVE, in our city. They were requesting we attempt to contact the owner to make sure the vehicle was not stolen. See call #080230151. On this date MAVE was not home but I spoke with PETTRY. He indicated the vehicle was not stolen, but being used by their friend, CARLOS. Detective Gray indicated this was the male they had in custody.
