Topic Original Report

M.O.: By placing an unknown object to the victims head, and taking her purse containing \$100 in miscellaneous bills.

On 2-3-08 at 1830 hrs, I responded to \_\_\_\_\_ regarding an elderly female that had been robbed at gunpoint near Walgreens. When I arrived on scene I spoke with VIC/LEANORA GENTILE and learned the following:

GENTILE is partially blind, and uses an electronic wheel chair to get around. GENTILE stated she left her apartment at approximately 1400 hrs today, to pay her bills at Drug Mart, 11900 Detroit. GENTILE placed \$100 dollars in her change purse and left. GENTILE indicates she always sits on her purse when she leaves her apartment. When she reached Walgreens, she decided she wanted a cup of coffee and drove up the driveway just west of Walgreens, off of Detroit, to go to McDonalds. GENTILE indicated when she reached the parking lot, she sat up and took her wallet out. When GENTILE reached McDonalds, she saw there was a long line and turned around back towards Detroit. When she reached the parking lot of Walgreens, she again sat on her purse.

When GENTILE reached the driveway, just west of Walgreens between the two buildings, a male walked up behind her and placed something against her head. GENTILE believed this object to be a gun. The male told GENTILE to put her head down and stand up. GENTILE asked the male not to hurt her. The male again told her to put her head down and to stand up. GENTILE complied. The male came around to her right side and took the purse off of her seat. GENTILE indicated she was unable to see the male, except for his right leg. The male was wearing blue jeans. GENTILE indicated due to her inability to see well, she could not get a description. It was also unknown what direction the male left. GENTILE indicated she was extremely scared and went directly home. GENTILE was unsure what to do so she lied down in bed. It wasn't until a friend called did she tell someone what happened. It was at this time her friend advised her to contact the police.

GENTILE was unsure if the male had touched her wheelchair. Inv. Mladek arrived on scene but found nothing of evidentiary value.
