| <p>On 2-2-08 at approx. 1400 hrs the complainant, MEDINA BOTIC, came to the station to report that one of the children she watches before and after school was stopped by a car on 2-1-08 and a male asked him if he wanted a ride home.</p> <p>BOTIC related that she helps her friend, OIV _____, with her children before and after school. BULEUL lives down the hall in the same apartment building. On 2-1-08 when OIV _____ 12 yrs, arrived home after school at approx. 1645 hrs. _____ had stayed after school for some type of activity. _____ informed BOTIC that as he had been walking NB on Riverside a black colored limousine pulled in front of him and a male in the back seat asked him if he wanted a ride home. _____ told the male no, and the car drove away.</p> <p>BOTIC contacted _____ at work, who advised her to let the school know about the incident. BOTIC called and left a voice mail message for the principal of Harding Middle School. BOTIC felt the police should know about the incident so she stopped in to the station on 2-2-08. I then called _____ and he stated that at approx. 1630 hrs he had been walking NB on Riverside on the east sidewalk. As he approached Fries Ave, a car, which he described as a black, averaged-sized limousine, came NB on Riverside and pulled onto Fries, blocking the crosswalk. The right rear window came down several inches and a male in the back seat asked _____ if he would like a ride home. The male in the back seat was described as a W/M with brown eyes, nothing further. _____ told the male he did not want a ride and he would continue to walk home. The vehicle then drove off EB on Fries.</p> <p>_____ stated he had never seen the car before and has not had any similar problems.</p> |       |                 |
