Topic Original Report

MO- By having in his shoe, a clear baggie of a green vegetable matter which the male identified as marijuana

On 02/15/2008 I was Eastbound on DETROIT passing BUNTS when I observed the listed Chevy parked and running with its lights on in the lot of the MOON'S FOOD STORE at 14000 DETROIT. As I passed the lot, I observed the vehicle appeared to be unoccupied. This agency took a report last month of a stolen vehicle from that location that was an unattended motor vehicle. I turned around near DETROIT and PARKWOOD, then pulled into the lot behind the Chevy. A male came out, got into the vehicle, and began to back out of the space as I was pulling in and exiting my cruiser.

I directed the male back into the space and notified Dispatch of the stop. The male was asked for his OL and produced it. He was identified as (ARA)GALVIN. GALVIN was informed of the reason for the stop, and apologized for leaving the car running unattended. He told me the vehicle belonged to his girlfriend's brother, (OWN)BLANKENSHIP.

I ran GALVIN and found he was valid. Once PTL. MCCARTHY and AUX. SPEARS arrived, I informed them that I wanted to obtain a consent search of GALVIN and his vehicle. I was aware that GALVIN has been arrested several times by our department for selling drugs. I had also stopped him previously driving another vehicle belonging to BLANKENSHIP.

I asked GALVIN to step out of the vehicle. He was told that he was being advised regarding the Unattended Motor Vehicle violation. I then asked him if he had anything illegal on his person or in the vehicle. He said no. I asked if he had a problem with me searching him, and he initially said no, but then said he had to get going to pick someone up. I then asked if I brought a dog to the scene, if it would alert on anything in the car or on his person. GALVIN appeared nervous and began using conditioning words like "honestly" when speaking with him. I instructed him to take his hands out of his pockets several times. I then began to pat him down due to him repeatedly placing his hands in his pockets, and told him that if he had anything illegal on his person, that it would benefit him to reveal it and cooperate. He then said he had marijuana in his shoe.

GALVIN took off his shoes and I retrieved a clear baggie of marijuana. A search of his person revealed no other contraband. Note that GALVIN had several stacks of money folded in the pockets of his pants. The approximate total was \$2000. GALVIN said the majority of this was from his business. GALVIN invited me to search the trunk of the car, and popped the trunk for me. In a pair of jeans in the trunk, I located the listed blue glass pipe with burnt residue commonly used to smoke marijuana. GALVIN swore, and then said the pipe was his brother's. I did locate paperwork in the back pocket of the jeans for "WILLIAM GALVIN".

GALVIN was issued Citation #M39089 for Drug Abuse. He was advised regarding the Unattended Motor Vehicle violation and the car not having rear plate illumination. He was sent on his way. I later tagged the marijuana and pipe, placed both in plastic evidence bags, and placed the bags into the drug chute in the secure property room at LPD.
