<b>N A R R A T I V E  1</b>	Topic	Original Report
<p>On 02/18/2008 at 0056, while on patrol through the MCDONALD's lot at 1430 W117TH, I was stopped by a male who identified himself as the owner of American Limosine. He told me that he just observed 4 black males trying to get into the business. I notified Dispatch and requested other cars respond to assist as I headed to the area.</p> <p>As officers arrived in the area, I observed a white Chrysler traveling South on COUTANT from DETROIT with no headlights on as I was Northbound. I activated the overhead lights in car 202 and pulled in front of the car while other officers pulled behind it to initiate a traffic stop.</p> <p>The driver of the Chrysler was identified as (OIV)WISE. The passenger was identified as (SUB)DUVALL. PTL. LEANZA had Dispatch check DUVALL through the computer, and it was discovered she had a warrant out of (GOV)LINNDALE VILLAGE POLICE DEPARTMENT for Failure To Appear for traffic charges. The warrant was confirmed by HARRIS of LINNDALE VILLAGE PD at 0111hrs. DUVALL was secured in 213, and transported by PTL. LEANZA to the White Castle on W117TH. She was then turned over to LINNDALE VILLAGE PD.</p> <p>WISE was issued Citation #D160413 for Lighted Lights- Times. He was advised of his insurance requirement. WISE told officers that he was coming from his aunt's residence around the corner. There was no damage found at American Limosine, and it did not appear that WISE was involved in an attempted break-in there. The area checked negative for the 4 black males.</p>
