Topic Original Report

M.O. - By forcing open the front door of the victim's apartment, by unknown means, and taking money, shoes, and electronics out of the residence without permission.

On 2-19-08, at approximately 2059 hours, officers were detailed to 1412 Ridgewood on the report of VIC/BRENDA REECE's residence having been broken into and items taken. Upon arrival, we spoke with REECE and her boyfriend, VIC/ WAYNE STAFFORD II, and learned the following:

According to REECE, she and STAFFORD have been living together in the apartment for approximately three months. They had both recently filed their income taxes and received their returns. Earlier in the day, on 2-19-08, REECE deposited part of the money into her bank account and took the rest of the money home with her. She hid the money in the top right drawer of her clothes dresser in their bedroom. Also located in the bedroom were STAFFORD's listed shoes and DVD player, which were placed on top the clothes dresser in their bedroom.

Both STAFFORD and REECE stated that they had been in and out of the residence throughout the day. They stated that they left the residence, the last time, at approximately 1630 hrs. When they returned home, at approximately 1930 hrs., they found their front door that appeared to be forced open and the listed shoes, DVD player, and \$2200 in cash were missing. REECE stated that all of the dresser drawers in the clothes dresser in their bedroom had been opened and several items in the room had been moved or thrown from their original place. Nothing else in the apartment appeared to be disturbed or missing.

Upon checking the residence, the door frame of the front door to the apartment had been split around the door lock. It appeared that the door was forced open possibly by pushing on the door. You enter the apartment into the living room. The bedroom is located down the hall to the west of the living room. The clothes dresser in the bedroom was situated along the north wall of the bedroom. There is only one other apartment door on the same floor as REECE and STAFFORD's apartment, however, they stated that apartment and the apartment directly below theirs are not currently occupied. The only other apartment that is occupied in the building is apartment #2 on the first floor. We spoke to the resident in apartment 2, but he stated he did not see or hear anything unusual throughout the day.

In further speaking with STAFFORD and REECE, they stated that no one knew that they had the money hidden in the drawer. STAFFORD, however, was able to give a possible suspect in the matter. He stated that a male, he only knows as "DRE," may be a suspect in the theft. He said that he does not know anything more about "DRE" other than his first name is "DEONDRE" and he lives somewhere in the area of W 98 and Madison. "DRE" is only an acquaintance of STAFFORD, but he has been to STAFFORD's residence on a few occasions to visit.

The reason STAFFORD suspects "DRE" is because another acquaintance of STAFFORD's described who he believes to be "DRE." STAFFORD walked outside after they returned home and found their property missing and ran into a male he only knows from the neighborhood as "JOHN." He has no further information on JOHN. STAFFORD asked JOHN if he had seen anyone in his building or around his apartment, and JOHN stated he had seen a couple of males at approximately 1730 or 1800 hours. JOHN stated that one of the males was dressed in all brown with white and tan shoes on. He was approximately 6' to 6'2, thin build and dark complexion. JOHN also stated that the male appeared to

have been beat up because of some lumps on his face. STAFFORD stated that description fits "DRE" perfectly. STAFFORD also stated that "DRE" has a permanent lump on his face under his left eye which makes it appear as if he had been hit in the face. JOHN stated there was also another male there. He could only describe the other male as a shorter, chubbier, light skinned black male. He was wearing a black jacket with a multicolored hood on. JOHN did not think anything was suspicious about the males being in STAFFORD's building because he had seen them their with STAFFORD on previous occasions.

The only other person at the residence while I was speaking with STAFFORD and REECE, was STAFFORD's sister, OIV/ AMBER DOUGLAS. She stated that she had received a text message on her phone from "DRE" at 1830 hrs on 2-19-08 asking if they were at STAFFORD's residence yet. They found the message to be suspicious after returning to the residence and finding the money and other items missing.

They were unable to give any further information about the suspects in this matter. Prosecution is desired also.

Inv. Pickens arrived on scene for ET work. Photos were taken of the damage, but nothing else of evidentiary value was located.
