Topic Original Report

M.O.: By striking the victim in the face several times, causing physical harm.

On 2/20/08, at 2055 hrs, Inv. Deucher and I responded to 1553 Mars. We were meeting a female who wanted us to stand by while she spoke to another parent regarding a confrontation between their sons. When I arrived on scene I spoke with OIV/ELIZABETH SPAIS and VIC/ W SPAIS indicated an unknown male physically assaulted her son, W this afternoon. Prior to being struck, the unknown male asked W what was going on with him and OIV/ L L is a male that W has been verbally fighting with since 2/19/08. SPAIS hoped to speak to L's mother to try to resolve the problem.

L answered the door and advised his mother was not home. While SPAIS spoke to L, she learned the boy's name that hit her son was SUS/JASON MOREHOUSE. L stated he was on the wrestling team with MOREHOUSE at LHS. SPAIS indicated she desired prosecution now that she knew the male's name.

I spoke with L and learned the following:

L indicated he and W had been in a verbal altercation on Tuesday, 2/19/08. W thought L had told W's girlfriend he had kissed another female. W became upset regarding the matter and confronted L in the hallway. The two argued, but went their separate ways. L said he later saw W at the Speedway located at 1511 Warren, where they were able to resolve their differences. L indicated he later received a phone call from OIV/S. H H told him she heard W was going to bring his ".38" to L's house to shoot him and his family.

On 2/20/08, L indicated he and W were supposed to fight after school. L said W left school, so the fight never happened. After school was over, L's friend, OIV/JASON MOREHOUSE, approached him in front of LHS in a vehicle. MOREHOUSE told L he saw W down the street and had hit him seven times.

I spoke with W and learned the following:

W stated he and L had been in a verbal altercation in the hallway at school regarding the rumor he believed L was spreading. W stated they yelled at each other for a little while and went their separate ways. As W was walking up the stairs, he heard an unknown male state there was going to be a shooting. W said he and L were supposed to fight after school on Tuesday, but he left school and went to a friend's house. After things cooled down, and the crowd dispersed, he walked home. As W passed Speedway, he saw L. They talked and were able to resolve the problem.

When W was at school today, 2/20/08, he heard someone told L that he was going to get a gun and shoot L and his family. W approached L in the hallway and told him this rumor was not true. L told him, "whatever, talk to S". W later heard he was supposed to be fighting L again after school. W stated he wasn't going to fight and walked right home at the end of the school day. When W reached the Speedway, 1511 Warren, a silver

Dodge Neon pulled up to him. Someone yelled out the window "come here". W didn't know the people were talking to him and kept walking. The car then pulled in front of him and a passenger got out. The unknown male asked W what was going on with him and L. When W started to tell him the story, the male swung at W and struck him on the left side of the neck/collarbone. When W attempted to back away, the male grabbed W by the coat, and began slapping him in the face several times. The male stopped and asked W "what do you think about that?" W told this male that H started rumors, and that he and L were "cool". The male then punched W on the left side of his face and stated "tell that to S". The male got back into the car, which drove away.

W had red marks on the left side of his face and neck. Inv. Deucher took photos. Both W and L denied making any comments about guns. W indicated he would recognize the male who punched him if he saw him again.

Ptl. Mance responded to SPAIS's residence this afternoon regarding the matter. SPAIS indicated she did not wish any further police involvement at this time, and that she would contact the school regarding the situation.
