1	<p>MO: By entering a home of another and removing a safe and its contents without the knowledge or permission of owner.</p> <p>Lt Warner Sir,</p> <p>On 02-20-08, at 2350 hrs, Inv Mladek and I were detailed to 2114 Dowd for report of a burglary. When we arrived we spoke with VIC/NATASHA EVERSOLE who said an acquaintance had taken the listed floor safe and its contents, about a hundred DVD recordings of movies, and \$300.00 cash. She said she paid \$50.00 for the safe, and the average value of the DVD's was estimated at \$10.00.</p> <p>She said she was at work and OIV/JAMES YOUNG called her at about 2300hrs of the same date, and said he came home and the safe was gone. EVERSOLE and YOUNG live together as boyfriend and girlfriend.</p> <p>YOUNG said SUS/DAVID (UNKNOWN LAST NAME), had come to play video games at about 1930hrs. He said he knows DAVID from the neighborhood. He said he did not know DAVID's last name. He guessed he was about 19 or 20, 601 or 602 tall, black hair and brown eyes, and a black male.</p> <p>YOUNG said DAVID asked to use the restroom twice, and had to go through the room where the floor safe was. YOUNG said at one point he removed the key to the safe from the drawer in the room where the safe was and got a couple of DVD's out. YOUNG said about 1840hrs they decided to go to 2120 Robin to play spades. DAVID said he needed to use the safe key to zip up his broken zipper on his coat. YOUNG got the key from the drawer and let DAVID use it to zip his coat, and returned it to the drawer. DAVID saw him remove and replace the key. He said he left the front door unlocked, as he usually does when he is in the neighborhood.</p> <p>YOUNG said about 5 minutes after they arrived at 2120 Robin, apt 2, DAVID said he was going to visit friends in apt 3. YOUNG said DAVID did not return, and he called DAVID at about 2100hrs. DAVID said he would be right there, but did not return. YOUNG said he went home about 23000hrs and saw the safe gone. He said the drawers were open on the dresser where the key to the safe was kept. He said he looked and the key was gone also. YOUNG said he felt DAVID took the safe and key because he noticed how closely he watched him put the key back in the drawer.</p> <p>EVERSOLE said she called DAVID on his cell phone when she came home and advised him to</p>

bring back the safe. She said he did not deny taking the safe. She says she does not owe him any money. While we were on scene EVERSOLE received a phone call, which she said was DAVID, and again advised him to bring back the safe. She said he told her this time that he didn't know what she was talking about.

Inv Miadek took photos of the scene and was able to find evidence of value. YOUNG showed me the house on Chesterland where he said DAVID lives, 2139 Chesterland. He was not certain.

Inv Miadek and I went to 2120 Robin apt 2 and spoke with OIV/TIFFANY KIMBROW who said that DAVID and YOUNG did come to play spades as YOUNG described. She said DAVID did leave for a while but came back, and eventually left with YOUNG.

I went to 2139 Chesterland and got no response at the door. While on Dowd, I knocked on two neighboring houses and got no response. EVERSOLE said a neighbor across the street watches her house for her. She said he is an elderly man and she will speak to him in the morning to see if he saw anyone leave the house with the safe.
