Topic Original Report

M/O#1:By having a loaded pistol concealed in his shoe.

M/O#2:By being in possession of a loaded pistol after having previously been convicted of a felony of violence.

M/O#3:By being in possession of a loaded pistol while being intoxicated.

M/O#4:By being voluntarily intoxicated and creating a risk of physical harm to himself and others.

Lt. Warner Sir,

On 02/23/08, at approximately 2053 hrs, P.O. GREEAR and I were detailed code 3 to the area of Idlewood and Clifton. Dispatch advised that they were on the phone with a female, later identified as COM/OCTAVIA ROGERS, who stated that her friend lived on Idlewood and there was a man at her house "waving a gun around". ROGERS advised that she did not know the address, but was currently driving to the house. I located ROGERS on Hird near Clifton. ROGERS drove south on Hird to Williamson, then west to Idlewood. She exited her vehicle and directed me to 1301 Idlewood as P.O. GREEAR and other officers were arriving.

ROGERS was on the phone with a female, later identified as OIV/JENNA EVANS. ROGERS was screaming that the male, later identified as ARA/ADAM FERGUSON, was still in the house with the gun. All ROGERS could tell us was that the FERGUSON was a white male wearing a white "hoodie".

Officers set up a perimeter around the house. The common door on the south side of the house was open, and there were several parties in the stairwell. P.O. GREER advised that he could see a white male on the second floor landing. P.O. GREEAR and I began ordering everyone in the stairwell out at gunpoint, while other officers secured them in handcuffs. While this was going on, ROGERS, who was still on the phone with EVANS, started screaming that FERGUSON was trying to get back into the second floor of the house. Everyone was eventually secured.

Myself and SGT. WILKINS entered the house and verified it was empty.

EVANS advised the following: Her friend OIV/JENNA FARMER, had organized a surprise, belated birthday party for her. FARMER was at the house when EVANS arrived home at approximately 2035 hrs. At this time they were the only two at the house. At approximately 2045 hrs, FERGUSON and several other males showed up at the house. EVANS had met FERGUSON approximately 2 weeks prior to today's date. She stated that on the night she met FERGUSON, he showed her the listed pistol. FERGUSON told EVANS that she wanted her to know he had it so she was not nervous around him. EVANS stated that on today's date when FERGUSON arrived at her house, he was highly intoxicated. She stated that FERGUSON entered her house and immediately went into her bedroom and fell onto her bed. She told the other males to get him out, as she did not like him and did not want him there in his current state. She stated that several of the males began smacking FERGUSON to wake him up. Ferguson began to stand up, and the pistol fell from the right side of his waistband. FERGUSON picked up the pistol and started walking into the dining room. He fell to the floor on top of the pistol. The other males began yelling at FERGUSON to put the pistol down. FERGUSON then

stood up and began waving the pistol around and yelling incoherently. Everyone "scattered". At this point ROGERS called EVANS to let her know that she was on her way over to the party. EVANS told ROGERS what was happening, and ROGERS contacted LPD.

EVANS stated that when officers arrived, FERGUSON was on the landing outside her door. EVANS had locked the door so that FERGUSON would not come back in. FERGUSON saw that we had arrived, and was pleading with EVANS to let him in so that he could "get rid of the gun". EVANS stated that she saw FERGUSON put something into her jacket, which was hanging on a hook outside her door. SGT. WILKINS located the listed holster inside of EVANS' jacket pocket.

EVANS also stated that she had seen FERGUSON putting something into his right shoe.

It should be noted that EVANS' door had a large glass window in it which would have given her a clear view of FERGUSON on the other side.

I responded back outside to where SGT. KAUCHECK was detaining FERGUSON. In checking FERGUSON'S right shoe, the listed pistol was located. It was found to have three rounds in the magazine, and one in the chamber.

FERGUSON was highly intoxicated. He had a strong odor of an alcoholic beverage on his breath, bloodshot glassy eyes, slurred speech, and was barely able to walk.

FERGUSON was advised that he was under arrest, and was secured in the rear of unit #206.

I had dispatch run the serial number on the pistol, and it checked NIF.

I transported FERGUSON to LPD jail where P.O. RUSNAK and I booked him in.

I later tagged that pistol, magazine, ammunition, and holster. I then secured them in locker #17 of the LPD property room.
