Topic Original Report

MO: By spitting on victim twice, and then push victim in her face in an attempt to cause injury to victim.

On 02/23/2008 I was detailed to Lakewood Hospital for an Assault report. Upon arrival I spoke to VIC/BEATRICE TUBBS who rode the same RTA bus to work today with her ex-boyfriend, SUS/MICHAEL WOODS. TUBBS and WOODS got off the bus when it stopped on Detroit at Belle Ave. TUBBS started walking Southbound on Belle from Detroit ahead of WOODS who caught up to her and stood in front of her. WOODS was upset the he and TUBBS broke up and WOODS stated he was going to beat TUBBS up. WOODS stood in front of TUBBS and spit on her face twice while she was trying to walk to work. TUBBS walked around and entered the hospital at the Belle Ave. entrance and WOODS followed her. WOODS followed TUBBS down the hallway that leads to the hospital kitchen and stopped in front of TUBBS by the elevator. WOODS took his open right hand and pushed TUBBS in her face causing her to lose her balance and move backwards. TUBBS did not fall from the push and was able to walk away from WOODS. TUBBS had no visible injuries and required no medical attention at this time.

I spoke to WOODS who stated he rode the bus with TUBBS this morning as he does every morning to be at work on time. WOODS denied spitting on TUBBS when they both got off the bus and were walking to work. WOODS also denied pushing TUBBS in her face in the hallway by the elevator. WOODS stated TUBBS was yelling at him and he was trying to walk away from her. Lakewood Hospital Security was with TUBBS and were also documenting the incident. TUBBS stated she is afraid WOODS would assault her again and desires prosecution in this matter. TUBBS also requested a restraining order against WOODS and she was advised of the procedure for doing so.
