

Topic Original Report

M.O.: By entering the VICs locked apartment by unknown means and leaving with the VICs laptop, Nintendo Wii video game system, DVD movies, and bottle of whisky without consent or permission.

LT Warner, sir:

On 2/24/2008, at 2104 hours, I was dispatched to 1179 Andrews, Apt 3, on a call from VIC/ASHLEY CYRUS stating her apartment had been entered and items were missing.

Upon arrival I spoke to CYRUS and VIC/JACQUELINE VARADY, who stated the following: CYRUS left her apartment on 2/19/2008 at approximately 1400 hours to attend to some family matters out of town. VARADY arrived at the apartment that evening at approximately 2030 hours. VARADY was staying at CYRUS' apartment to care for CYRUS' dogs while CYRUS was out of town.

Apt 3 is located on the north side of the second floor of 1179 Andrews. The door to apt 3 opens to the main family room.

When VARADY entered the apartment, she noticed her Nintendo Wii video game system was missing from its place beside the television, against the west wall of the family room. The Wii belongs to VARADY. VARADY assumed CYRUS had moved the Wii to a safe location because her dogs chew on the game controls and cords.


VARADY stated the apartment was locked when she arrived, and she unlocked the door using keys given to her by CYRUS. CYRUS has a set of keys and gave another set to VARADY. CYRUS stated her landlord also has keys and an old roommate still has keys, but does not consider them suspects.

When CYRUS arrived home to her apartment today, at approximately 1230 hours, she discovered others items missing in addition to VARADY's Wii. The listed HP laptop was missing from the family room as well as approximately 50 DVD movies. A few more DVD movies were missing from CYRUS' bedroom, and a bottle of whisky was missing from the top of the refrigerator in the kitchen.

There is a back door to the apartment that is kept deadbolted at all times. The front door also has a deadbolt. There were no signs of forced entry on either door. There is a door to the apartment balcony to the west, which is kept unlocked.

Inv Pickens arrived to perform ET work. He photographed the scene and nothing further of evidentiary value was found.

VARADY will attempt to locate the serial number for the Wii. CYRUS does not have the serial number for the laptop. CYRUS will compile a list of DVD titles that are missing. CYRUS and VARADY desire prosecution and have no suspects.
