<p>MO: By entering vacant home by unknown means, cutting copper plumbing pipe from basement and taking same without owners permission</p> <p>On 2-27-08 at 1055Hrs. I was detailed to 1498 Hopkins on the report of copper plumbing being taken from a vacant house.</p> <p>On arrival I spoke with COM/MICHAEL PAVLIK who explained the following. He is the property manager for CPY/WESTWAY REALTY and checks the status of several homes. He entered this locked home today and found that the hot water tank in the basement had been moved and that copper piping had been cut and removed. PAVLIK was not sure when this occurred since the home had been found broken into a few times over the last couple of months. The back door had been recently secured after being broken in. PAVLIK was not sure when this happened and believes that the missing piping had gone unnoticed. He thinks that it could have been taken some time over the last month.</p> <p>PAVLIK did not see any broken windows or doors today.</p> <p>PAVLIK advised that he does not know who owns the home.</p> <p>Upon entering the home, I observed several discarded items from the previous tenants, consisting of old clothes, paperwork and misc. items scattered about every room. Most of the basement floor was covered with misc. items as well.</p> <p>About fifteen feet of copper pipe appeared to be missing from the ceiling in the basement. It had been cut from above the water tank and at the opposite end of the basement.</p> <p>Some portions of copper pipe had been left in the basement.</p> <p>INV. Crumley responded for ET work. He attempted to process the water tank but found nothing of value. He took photos of the scene.</p> <p>The nearby neighbors homes were checked. We received no answers at the doors.</p>
