Topic Original Report

MO: By grabbing and throwing victim onto the floor, causing her to land on her back and right elbow, injuring same

On 2-28-08 at 0825Hrs. I was detailed with other officers to Summit and Detroit to meet a female who stated that she had been assaulted by her husband at their home at 1279 Summit.

On arrival I spoke with VIC/ who relayed the following and later gave a written statement to the same. She was in the living room getting her two young girls dressed. was on the couch and having difficulty with her small daughter, OIV/ , who was fussing. tapped her on the leg, trying to straighten her for changing her diaper. 's husband, ARA/MICHAEL TANNER, who was on the other end of the couch, yelled at her, telling her not to touch the children. told him to relax, that she only tapped MICHAEL then got up, grabbed by the front of the shirt and slammed her down onto the living room floor. She landed on her back and right elbow and had severe pain in both. She was unable to get up for a moment. then got up and finished getting and her other daughter, OIV/ , dressed. During this time, MICHAEL was yelling and stated that she was lucky that this was all he did to her. then told him that she was going to take the girls to their day care. MICHAEL told her that she was not taking theme anywhere. then quickly left the house, got into her car and drove up the street where she phoned us.

stated that MICHAEL is the father of and . He has assaulted her in the past but she has never reported the incidents. further stated that MICHAEL abuses alcohol and had been drinking last night. Both daughters witnessed todays assault. has an older son, OIV/ from another relationship who was at at the time of the incident.

complained of pain in her back and right elbow. She refused an ambulance, stating that she wanted to take her girls to day care and drive herself to Lakewood Hospital later.

stated that she desired prosecution against MICHAEL for Domestic Violence and wanted a protection order against him.

Dispatch advised that MICHAEL had a contempt warrant out of our department for failure to appear on an OVI.

I then responded to the house with PO Eikens, INV. Geary and SGT. Wilkins. I knocked on the front door with SGT. Wilkins. MICHAEL looked out of the front window at us, sat down on the couch and refused to come to the door. We could see and walking around in the living room. I then met next door and advised her of the above. She handed me her keys and advised us to enter the house, via the side door.

I entered the side door with other officers and proceeded into the living room. MICHAEL was still sitting on the couch with next to him. was walking around in the room. stated "He pushed mommy on the floor." I then asked MICHAEL why he did not answer the door. He gave no answer and I advised him to stand up and place his hands behind his back because he was under

arrest. He stood up and was compliant. I then handcuffed him and walked him out to PO Eikens unit, #209.

PO Eikens transported MICHAEL to LPD. There he and CO McCarthy booked MICHAEL for Domestic Violence and the warrant.

came back to the house and transported and to her day care provider at . I followed her there and then to the Lakewood Hospital Emergency Room. There she was treated by Dr. Hinsberg who later advised that she had only bruising.

While was being treated, I obtained a written statement. INV. Geary responded there also and took a photo of 's right elbow which had a fresh abrasion and swelling.

was provided with a resource card.

I later contacted the Domestic Violence Hotline and relayed information to Edie. I also contacted CWWV and relayed information to Brenda. 696-Kids contacted
