Topic Original Report

MO1: By entering the victim's residence by unknown means and without consent and taking numerous items from the residence.

SGT. WILKINS, Sir:

On 3-4-08 at 1309 hrs. I was detailed to 2029 Chesterland Ave. on the report of items missing from the house.

On arrival I spoke with VIC/BARBARA MOLNAR. MOLNAR stated that she resides with OIV/ERIC JOHNSON. MOLNAR further advised that she had recently been released from the hospital after having brain surgery. MOLNAR had been in the hospital from 12-10-07 to 2-18-08. Due to her medical condition, MOLNAR has had difficulty moving around in her residence. She advised that since she has been home she has noticed several items missing from her house. MOLNAR added that while she was hospitalized, JOHNSON spent several weeks in the hospital for various medical conditions.

MOLNAR stated that she believes the former upstairs tenants, SUS/ANDREA DENT and SUS/NICOLE SMITH took all of her items. MOLNAR added that they had been evicted sometime in either late January or early February. MOLNAR believes that DENT and SMITH took her belongings while they were moving out of the upstairs residence. MOLNAR desires prosecution.

MOLNAR stated that of the items taken, an urn containing the ashes of her dog were also stolen. She advised that this item was kept in her bedroom closet. She did, however, get the urn and remains back. MOLNAR stated that JOHNSON was walking on Chesterland Ave. about a week ago when he was approached on the street by a white male. The male asked him about items missing from the house. Then he told JOHNSON that he had MOLNAR's urn and the dog's ashes. He then took JOHNSON to his apartment on Madison Ave. and gave him the urn to return to MOLNAR. It should be noted that JOHNSON had been drinking prior to being approached by the male and could not recall the male's name or where on Madison Ave. he lived. He did tell MOLNAR that he had seen this male at DENT and SMITH's residence before and that the male was friends with them. Also the male reportedly told JOHNSON that DENT and SMITH took JOHNSON's property and they have it in their current apartment.

MOLNAR believes that more items may have been taken from her storage area in the basement. However, due to her medical condition, she cannot climb stairs to see if anything else is missing. MOLNAR desires prosecution, but does not know where DENT and SMITH moved to.

I spoke with OIV/JOHN SLAVIK via telephone. SLAVIK is the property owner and 2029/2031 Chesterland Ave. He stated that DENT and SMITH moved out in early February. He added that DENT and SMITH were section 8 renters and the CPY/EDEN CORPORATION paid DENT and SMITH's rent. SLAVIK called the EDEN CORPORATION to try and find where DENT and SMITH had moved to. They refused to tell him exactly where they moved to, but that they rented another residence in Lakewood. When I spoke with SLAVIK, he did not have the phone number of EDEN CORPORATION. Additionally, I was unable locate any further information on the EDEN CORPORATION.
