Topic Original Report

MO; By having an open bottle of Crown Royal whiskey by front seat while driving an auto.
MO; By having four separate clear baggies with green vegetable matter inside that tested positive for marijuana.
MO; By having a cell phone believed to be used as a criminal tool in conjunction with the sealed marijuana baggies.

On 3-5-08 at 1323 Hrs., INV. MALLOY and I were detailed to 12050 Lake on the report of a party in a grey, Cadillac auto drinking alcohol. On arrival, INV. MALLOY observed the grey, Cadillac auto drive out of the parking lot, he subsequently stopped the auto at 11706 Clifton. I arrived at this point, INV. MALLOY ran driver, ARA/RICHARD BARON and learned he had a warrant for his arrest. Dispatch advised that RICHARD had a felony Recieving Stolen Property warrant out of C.C.S.O. I ran passenger ARA/TAMIKA DIXON, she was not wanted and was under a driving suspension.

Dispatch confirmed the warrant with SEALS of C.C.S.O., RICHARD was placed under arrest and handcuffed. RICHARD was then secured in my car #219.

Prior to towing the auto, during the inventory search, I located a "Crown Royal" whiskey container that was two thirds empty underneath the front drivers seat. Note, RICHARD denied drinking and he was not intoxicated. I then located a plastic tin behind the drivers front seat, I opened it and it had two clear baggies with green vegetable matter in them believed to be marijuana. I then located another white plastic bottle, opened it and it had two more clear plastic baggies of green vegetable matter in them believed to be marijuana.

I checked the passenger front glove compartment and located \$100.00 in cash in a rubber band. I confiscated this money. In checking the trunk, RICHARD had Parking lot tickets with \$48.00 secured to it with a rubber band. Note, RICHARD claims to work for Parking. Twelve parking ticket stubs were missing and each ticket was \$4.00 that would total \$48.00. I did not confiscate this money from RICHARD.

I advised RICHARD of his Miranda rights, he said the green vegetable matter is not his. RICHARD said he was not going to talk about this anymore with me. Note, I confiscated \$147.00 in cash with a rubber band around it in RICHARD's right front pocket, along with a cell phone that RICHARD said was his.

I read DIXON her Miranda rights, she denied any involvement with the green vegetable matter. DIXON said RICHARD is a friend of hers and he was just taking her to Wendy's restaurant for lunch.

I advised RICHARD he was now under arrest for Trafficking in Marijuana, Open Container, and Criminal Tools.

I advised DIXON she was under arrest for Trafficking in Marijuana. SGT. FAVRE transported DIXON to LPD jail and she was booked by CO BUNNER. DIXON was strip searched and nothing was found. DIXON was then placed in a holding cell.

I transported RICHARD to LPD jail, he was booked by CO BUNNER and strip searched. Nothing was

located. RICHARD was then placed in a holding cell.

I tested the green vegetale matter with the Narco kit, it tested positive for marijuana.

I tagged the U.S. currency, the marijuana and cell phone. The U.S. currency and marijuana were placed in the drug chute. I placed the cell phone in locker #18 in the property room.

I then spoke with LT. CIRESI about this arrest, he advised me to write misdemeanor tickets for RICHARD and DIXON.

I wrote RICHARD M37013 for Open Container, M37014 for Drug Abuse and M37016 for Criminal Tools. I wrote DIXON M37015 for Drug Abuse. DIXON was subsequently released on citation.

RICHARD was to be held until he could be released to C.C.S.O. on their R.S.P. warrant.

Note, the owner of the auto is OWN/HELENA BARON. HELENA was notified by RICHARD about her auto being towed to Kufners towing when he made his call at the booking window.
