Topic Original Report

M.O. By grabbing victim and shoving him up against a wall and then placing a knife against his side, demanding victim's wallet.

On 3-6-08 at approx. 1500 hrs the victim, TIMOTHY R. LANUM, came to the station to report being robbed the evening before.

LANUM stated that on 3-5-08 at approx. 1930 hrs he was leaving Drug Mart (east) and started walking WB on the north sidewalk of Detroit Ave carrying two bags of items. As he reached a brick building, possibly the Five O'Clock Bar, a male grabbed him from behind and shoved him, face first, against the brick wall. The victim stated he quickly turned around when he was first grabbed and got a look at the suspect. The suspect is described as a B/M approx. 35 yrs, about 5'9" and 180#s with a slight moustache. He was wearing dark jeans and a black "hoodie" with the hood drawn tight around his face.

The suspect then produced what was described as a large kitchen knife and put it against the victim's right side. The suspect then said, "gim'me your wallet" which the victim did. The suspect quickly went through the wallet and found no cash. The suspect then apparently switched the knife to his left hand and used his right hand to reach into the right front pocket of the victim's jeans and pulled out a roll of cash. The roll of cash was from two social security checks recently cashed and a total of \$1,450.00 was stolen. The suspect then punched the victim in the side of his head, knocking him to the ground, partly due to the icy conditions.

LANUM stated he watched the suspect run EB through the Drug Mart lot and then NB along the east side of the building towards the muni lot. The suspect took the victim's wallet along with the cash. The victim then walked WB along Detroit and thought of stopping at the police station to report the incident, but continued walking to his friend's apartment, OIV RAY WASHINGTON at

The victim admitted to consuming several beers during the day (his birthday) and acknowledged that this may have influenced his decision not to stop at the station as he passed it. LANUM related that he normally keeps his cash separate from his wallet. He stated he took the whole roll of money out of his pocket to pay for his purchases at Drug Mart and the suspect may have seen his money. LANUM stated he was interested in prosecution and provided a written statement. He also requested the report number as he was going to attempt to get his social security checks re-issued. LANUM is presently between residences and has been mainly staying with WASHINGTON.

Drug Mart may have some store cameras which may have captured shots of the victim and possibly the suspect. The victim did not sustain any injuries and was wearing a heavy coat and sweatshirt at the time of the attack.
