	<p>MO:By using a key to gain entry to apartment then force open padlocked bedroom door and remove T.V. and video game unit and leave with same.</p> <p>3-6-08, Inv. Kulczycki and myself were detailed to 1491 Coutant #2 on report that the apartment was broken into and items were taken. Upon arrival, spoke with VIC/ DENNIS CHISHOLM who reported the following. He stated that he had allowed SUS/ DARYL MCGINNIS and a female stay at his apartment for a few weeks to do them a favor. He stated that last weekend he told them that they had to leave because they brought the police around his apartment and he did not want that (see rept. 08-001755 for details).</p> <p>CHISHOLM stated that MCGINNIS and the female were not happy with that and he stated that he has heard them in the apartment directly above him, which is #4, since then. He stated that while they were living with him he had given MCGINNIS a key for the door in the common hallway but thought that he got it back when they left. He stated that he met MCGINNIS and the unidentified female through the tenant in #4.</p>

CHISHOLM stated that he has kept a mattress against that door in an attempt to keep MCGINNIS and the female out while he was at work. He stated that when he comes and goes from his apartment that he uses the front door instead of the door to the common hallway. He stated that when he came home after work today he found that the mattress had been moved away from the door and his padlocked bedroom door had been forced open. He then found that the listed property was missing.

The apartment building shares the addresses of 1489/91 Coutant. Apartments 1 & 3 use the 1489 address while apartments 2 & 4 use 1491. CHISHOLM's apartment is on the first floor and has three entry doors; front, common hallway and rear door. The apartment is a two bedroom apartment and the one that MCGINNIS and the female stayed in was off of the kitchen at the far east end. CHISHOLM's bedroom was off the hallway between the kitchen and the dining room. The door had been padlocked since MCGINNIS and the female moved in. This door was body forced open which pulled the screws, for the hasp, out of the hollow core door. The four wood screws were still in the holes of the hasp.

The listed television had been on a table along the east wall of the bedroom. The suspect disconnected the cable TV wires and removed the television. The Playstation 2 console was taken from a table that was next to the television in the living room. The information for the stolen television was taken from the original box that CHISHOLM had in a closet.

Inv. Kulczycki and I responded to apartment #4 to speak with the resident but did not get an answer. While we were standing outside the building, a female came from around the back of the building, and went to enter the front doors. When she saw us, she had a nervous look on her face. We went and spoke to her and found that she was the tenant in #4, OIV/ MARY SLATER. SLATER seemed very nervous and evasive as she was she was talking to us. She was asked if she knew MCGINNIS and she stated that she didn't but she knew a guy named "Junior". She stated that she did not have anyone staying with her.

Inv. Kulczycki responded to apartment #2 and had CHISHOLM come out to identify SLATER as the person he met MCGINNIS through. He stated that she was the one who lived in #4 and who let MCGINNIS and the female stay with her. He also stated "she knows what this is about". After he went back to his apartment, we spoke to SLATER about the burglary, she asked us if we wanted to know the truth. She stated that she was in rehab for a cocaine addiction and was gone for a few weeks and that is when she let MCGINNIS and the female stay at her apartment.

SLATER stated that CHISHOLM is a crack user/dealer and that is why he kicked MCGINNIS out of his apartment for bringing the police around on 3-3-08. She stated that shortly before the police arrived, MCGINNIS told her to meet her in the basement in a few minutes. He then went into CHISHOLM's apartment and CHISHOLM was home at the time. She stated that she waited for a while, MCGINNIS did not come to the basement and she decided to go back to her apartment. That is when she came around the building and saw the police cars out front. The basement was checked with negative results. SLATER agreed to let us check her a apartment for the items that were missing from CHISHOLM's apartment and the items were not located.

Both CHISHOLM and MCGINNIS have a CCH for drug offenses. On 3-3-03, MCGINNIS was arrested by this department for trafficking in crack cocaine.
