in the loading dock area of the business. INV REGISTER maneuvered the patrol car into the parking lot and illuminated this area. KOVALCHUK was illuminated and immediately scaled the fence located on the West side of the business. We traveled to the area of 1581 Coutant and stopped the patrol vehicle to search for KOVALCHUK on foot.

A brief search of the area located KOVALCHUK in the rear of 1577 Coutant. I scaled a fence in the backyard between 1581 and 1577 Coutant in pursuit of KOVALCHUK. I identified myself and ordered him to stop. KOVALCHUK failed to comply with these directions. He jumped a fence in the driveway of 1577 Coutant to avoid me. INV REGISTER was in front of KOVALCHUK in the driveway at this time. INV REGISTER identified himself and ordered KOVALCHUK to stop. KOVALCHUK ran directly into INV REGISTER, at which time the male was taken to the ground in an attempt to detain him.

The male continued to actively resist while on the ground by attempting to get up, moving his arms underneath him and kicking his legs. KOVALCHUK was advised that he was under arrest at this time and continues to resist in this same manner. Assisting officers arrived on scene and assisted in detaining KOVALCHUK. In this process, pepper spray was administered by INV DEUCHER so that control of the subject could be obtained. PO GAMPHER assisted in the handcuffing of the male after control was established. KOVALCHUK continued to resist while being escorted to car 212 by refusing to move his legs.

Once secured in car 212, KOVALCHUK was decontaminated with Seudocon wipes and appropriately advised of the decontamination process. KOVALCHUK was further decontaminated once at LPD jail by using the eye decontamination station in the jail.

Assisting officers checked the area of Aldi's to 1577 Coutant and found no signs of criminal activity. PO Mullen spoke with VIC/ RONALD D WARIX, resident of 1577 Coutant. WARIX advised that he desires prosecution for Trespass. Due to the late hour, CPY/ ALDI'S was closed and no representative was contacted.

There was a language barrier between KOVALCHUK and officers. We learned that KOVALCHUK spoke Russian and had difficulty understanding our conversation. At the booking window Language Line was contacted at 1-800-752-6096. INV REGISTER spoke with representative Sergei, operator 6358. He provided translation services for the booking.

We observed cuts on KOVALCHUK's hands. We believe that these cuts occurred as a result of him jumping over fences. He was given alcohol pads and band aids to address these minor cuts. He refused further medical attention.

The male was issued Citations M40008 for Trespass, M40009 for Resisting Arrest and M40007 for Obstructing Official Business. The male was booked under No. LK 08-001977, fingerprinted by INV REGISTER and released on citations.
