Topic Original Report

M.O. - By taking victim's computer and keys from residence without permission.

On 3-9-08, at approximately 1950 hrs, I was detailed to 1630 Waterbury on the report of VIC/ laptop computer having been taken. Upon arrival, I spoke with and learned the following:

On 3-7-08, three people came to residence to talk with her because she had been feeling depressed. only knows them by their first names of "MIKE", "MONIQUE", and "CHRIS". stated she has not known any of them very long, and had met them in counseling. According to , MIKE, MONIQUE, and CHRIS all came to her residence around 1000 hrs on 3-7-08 because she called them and wanted to talk about her situation. said that while they were there, they were walking around her residence, which made her uncomfortable. asked them to leave at that time. After they left the residence, noticed that her laptop computer was missing.

stated that it was sitting on the living room floor in front of the TV where it was plugged into the cable Internet. When she went back to use the computer, after MIKE, MONIQUE, and CHRIS left, the computer was no longer there. stated that she was also missing her keys to her apartment door. Both the keys and the computer were in the living room prior to MIKE, MONIQUE, and CHRIS leaving the apartment.

contacted LPD at that time and Ptl. Jerdonek responded to the residence and spoke with . At that time, advised that she did not want any further police involvement and she was going to attempt to get the computer back on her own.

contacted LPD again on 3-9-08 for this report, when she was unable to retrieve her computer. She stated that she attempted to get her computer back from CHRIS, MIKE, and MONIQUE at MIKE'S residence, on 3-7-08 during the evening. She said that she believes that MIKE and CHRIS live at the address she was at, which was 4703 Franklin. She did not have any further information on MIKE, MONIQUE, or CHRIS. In checking the address and phone numbers in the computer, no further information was found on any of the parties either. also stated, however, that they were calling her from MONIQUE'S phone asking how much she was willing to pay to get her computer back.

While I was at the residence speaking with , I contacted MONIQUE at the number in phone and spoke with MONIQUE. She stated that she has never been to residence and knows nothing about a stolen computer or keys from residence. MONIQUE would not give any further information over the phone.

I also attempted to contact MIKE using the number had for him, but there was no answer at that number.

stated that prosecution is desired in this matter. was advised regarding solvability.
