	<p>M.O. By prying open the back door with some sort of metal tool to enter the business without the owners permission to do so.</p>	
	<p>On 3-10-08, at 0531 hours, I was detailed to 18616 Detroit, regarding a motion sensor alarm that was activated. Upon arrival, P.O. PERHACS and I found the rear door to the business open. The door looked like it was pried open by some sort of hard metal object. The weather strip along the dead bolt was stripped. There was also a 3"x18" window that was broken out. INV. PICKENS responded to assist and take photos of the door and window.</p>	
	<p>The back door leads to the basement steps. The basement has an east and west door to it. The east door leads to a cooler. The west door leads to a storage room. Both doors were locked and were not entered.</p> <p>VIC/MICHAEL KRIVOSH arrived and was informed of the damaged door. KRIVOSH has no suspects</p>

nor does he know of anyone who would do this. In speaking with KRIVOSH, he advised he has a security camera by the rear door of the business. Officers were able to watch the security footage of the break-in.

There were two suspects who entered the rear of the business. The first suspect had a black coat with a hood, blue jeans, and a black hat with foil stickers on the brim. The second suspect had blue jeans, a black jacket with white sleeves, and a black hat also. Officers could not get a good description of the faces. The video footage showed the suspects were inside for approximately two minutes. I was not able to obtain a copy of the surveillance tape at that time.

KRIVOSH desires prosecution in this matter.

On 3-12-08, I was able to obtain a copy of the surveillance tape. It was tagged and placed as evidence in locker #18 of LPD'S property room.
