Topic Original Report

MO: By entering home to remove a computer and television and then leave with same without the victims consent.

On this date INV. MOHER and I were detailed to 13984 Clifton for a Burglary report. Upon arrival we spoke with COM/REGINALD WASHINGTON who lives at this address with his mother, VIC/PAMELA DAVIS. WASHINGTON returned home at 1640hrs. after he was out all night and noticed the Compaq Computer in the dining room was missing from the computer stand. WASHINGTON checked the house further and noticed the Sony Television was missing from an upstairs bedroom where DAVIS sleeps. WASHINGTON stated the house was locked when he came home this afternoon. WASHINGTON contacted DAVIS who was returning home at this time.

INV. MOHER found no signs of forced entry and found nothing of evidentiary value inside the home. The home is a duplex with a front and rear door, and bars on the basement windows. The front door leads into a living room and dinning room area. There is a kitchen off of the dinning room area which leads to a back door. There is a stairwell from the living room area that leads to the upstairs. There are three bedrooms and one bathroom upstairs. DAVIS' bedroom is in the North end of the house upstairs. There is a night stand against the North wall by the bedroom entrance where the 27" Sony television was.

DAVIS arrived and indicated she arrived home about 1410hrs. after work. DAVIS noticed the items missing at that time but did not call the police because she knew who stole her television and computer. DAVIS believes her nephew, SUS/ entered the home and stole her television and computer. Three years ago DAVIS had custody of through the county because 's mother was unable to care for him. lived with DAVIS and WASHINGTON for two years until went back to his mother's house to live. DAVIS indicated had keys to her house and did not return them when he moved back with his mother. has not lived with DAVIS for a year but she has been missing about \$1,400.00 since moved out. DAVIS suspects of stealing her money but she has not been able to prove it. DAVIS desires prosecution of in this current theft of her computer and television. DAVIS does not have a current address for who she stated stays with friends every few days. DAVIS does not know the address is using on Harvard. DAVIS stated does not drive or know who would be driving him around after he stole her computer and television.

INV. MOHER and I checked with the following neighbors for suspect information. 13976, 13980, 13983 and 13988 Clifton did not see anything. There was no answer at the following address, 13979 and 13986 Clifton. I checked CRIS for further information on and found he has an open warrant with Juvenile Court for Felonious Assault. Warrant number [REDACTED] was issued on 09/11/07 for this offense from 06/18/07. I called the intake office at Juvenile Detention and was advised they would still take for this charge.
