NARRATIVE

Topic Original Report

MO1: By having a small plastic baggie of green vegetable matter, consistent with that of marijuana, found in his right front pants pocket.

MO2: By causing a disturbance in a business parking lot and on a city street by yelling obscenities to bar patrons, bystanders, and police while being instructed several times by officers not to do so.

On 03/13/08 at 0244 hrs., while responding to McCarthy's Ale House on another call, PTL HARNER and I were approached by a white male, later identified as (ARA)THOMAS DONALDSON, who was running out of McCarthy's parking lot toward Detroit Ave. while yelling obscenities. DONALDSON was yelling that he had been robbed of his marijuana and that he had just been beaten. DONALDSON was advised to calm down and stop yelling obscenities, but he refused to comply. He continued to swear at the bar patrons who were outside, calling them "Fuckers and Niggers". I again advised DONALDSON to stop using vulgar language, to quiet his voice, and not to use racial slurs. He told officers to "Fuck off" several times and continued to call officers and the bar patrons "Niggers". DONALDSON was immediately placed under arrest for Disorderly Conduct (M4) and secured in handcuffs. While searching DONALDSON, PTL HARNER found the listed baggie of marijuana in DONALDSON's right front pants pocket. He was advised of the Drug Abuse charge as well. DONALDSON was placed in the back of patrol unit #210.

PTL HARNER and I spoke with several patrons in the parking lot who witnessed the incident. We were advised that DONALDSON approached a group of males who exited McCarthy's and offered to sell them some marijuana. When they told DONALDSON to leave, DONALDSON became combative, saying that he was "Brooklyn", and that he could "Take them down". When officers arrived on scene, this is when DONALDSON ran toward Detroit Ave. yelling obscenities. No one involved wanted police involvement, so they left the area.

DONALDSON was transported to LPD and booked in by PTL RUSNAK and myself. DONALDSON was found to have in his possession, the listed credit card. DONALDSON stated that the credit card was not his and that the bar tender at McCarthy's gave it to him accidentally. DONALDSON was issued citation #M39225 for Drug Abuse (513.03) and citation #M39226 for Disorderly Conduct-Persistent (509.03e). DONALDSON has a CCH showing FBI #715818RC6, BCI #C287213, and Lakewood #21990.

I contacted (OWN)DANIEL KRYSIAK, who advised that he lost his wallet at the North Olmsted Plaza on 03/08/08, which had his driver's license, credit/debit cards, and other miscellaneous items in it. KRYSIAK stated he did not file a lost property report with police and he cancelled all his credit/debit cards on 03/11/08. KRYSIAK stated that at the time of this report, there has not been any activity or attempted activity on any of his cards. KRYSIAK said that if he does find any pending charges on any of his cards, he will prosecute.

The marijuana was weighed, tagged as evidence, and placed down the drug chute in the property room. The bank card was tagged as hold for owner and placed in locker #13 of the property room.
