

Topic Original Report

M.O.: By forcefully opening the downstairs rear door of a two family dwelling and taking a laptop computer without the owners consent

LT Sprague, Sir,

Detailed to 1562 Lakewood on 3/14/2008 at 1745hrs on the report of a burglary. Arrived and spoke with VIC/SUSAN LUCAS.

LUCAS advised that she did not notice the burglary until she had been home for 10-15 minutes. LUCAS' back door had been forced open. The door opens into a common hallway, shared with the upstairs residents at 1560 Lakewood. The door is on the west side of the residence in the kitchen area. A few pieces of the inside door jamb were on the floor in the kitchen. INV KULCZYCKI was detailed and photographed the damage. No other related damage was found throughout the residence.

LUCAS advised that the only thing she found to be missing was her laptop computer. It was located on a desk in the front hallway on the east end of the residence. LUCAS described it as a grey Dell computer, but did not have any further information about it. LUCAS stated that she bought it from the company she works for and will try to recover paperwork from the purchase. Any information LUCAS finds will be forwarded to LPD. INV KULCZYCKI photographed the scene. No other rooms appeared to have been disturbed and no other items appeared to be missing.

It should be noted that items such as gold/diamond wedding rings, loose change, and other assorted valuables did not appear to be disturbed. A small plastic bag of "junk" jewelry was found on the desk next to where the stolen laptop had been. LUCAS did not put it there. The jewelry had been in a small box on a shelf in the dining room. None of the jewelry was valuable.

LUCAS does not know who could be responsible. She has lived at 1562 Lakewood for approximately two months. LUCAS left for work on the day of this report at about hrs. This is about two hours later than her usual time. LUCAS advised that she comes home for lunch days per week from hrs, but did not do so on the day of this report. She arrives home daily at approximately hrs. LUCAS has kept the same routine since she has lived at 1562 Lakewood.

Before clearing the scene, I spoke with OIV/KATHLEEN D'AMICO. D'AMICO resides upstairs from LUCAS at 1560 Lakewood. D'AMICO advised that she was not home from 0900hrs-1600hrs. D'AMICO did not hear or see anything unusual during the time that she was at home. It did not appear as if an attempt was made to burglarize D'AMICO'S residence. No other residents in the immediate area were located to be spoken with at this time.

LUCAS was advised of the low solvability of this case. LUCAS will prosecute.
