Topic Original Report

MO: By refusing to leave the bar after being instructed by officers several times, while officers were trying to clear the bar of parties fighting.

Sgt. Eschweiler, Sir:

On 3/16/08, at 0045 hours, all working officers were detailed to 11794 Detroit for a fight inside the bar. On arrival we noticed parties arguing outside. We separated the parties and they were not physically fighting.

PTL MULLEN went inside the bar and advised that it appeared as if parties may be fighting inside the bar. Officers went inside. There were several groups throughout the entire bar that were arguing and pushing one another. The bar tender advised that he wanted everyone to leave before they got out of control. We shouted to everyone to leave. All parties started to exit. Two males were standing inside the bar just east of the entry doors. They were told again to leave. They told officers that they were not leaving. They were escorted outside and advised that they were under arrest for obstructing official business. They were secured in handcuffs.

One of the males was identified as ARA/ HECTOR ORTIZ. He was secured in the rear of unit #204. The other male was identified as ARA/ RICKY ORTIZ. These males are cousins. RICKY was secured in the rear of unit #216.

I spoke to the bar tender and he was identified as COM/ GARY WYSOCKI. He advised that he was not aware of what started the altercation within the bar. It should be noted that there is no telephone for the bar. WYSOCKI call LPD from his cell phone. All parties left the area.

PTL MINTEER transported HECTOR to the station. He was booked by CO Dan McCarthy for obstructing official business. He was issued citation #M39737.

PTL GAMPFER transported RICKY to the station. He was booked by CO Dan McCarthy for obstructing official business. He was issued citation#M40325.
