

<p>Lt Warner Sir:</p> <p>On 3/16/08 at 0154hrs officers were detailed to 14228 Athens-Dn on the report of males fighting. One male was reported to have been stabbed with a screwdriver. Cars were sent code 3.</p> <p>On arrival officers spoke to COM/DALE LEAMAN who said that he and OIV/JOSEPH GALLO had a heated verbal altercation. LEAMAN said that he thought that it may escalate so he got a screwdriver to defend himself, while he called LPD. LEAMAN said that when GALLO found out LPD was being called he left the house in an unknown direction. LEAMAN said that he was not hurt and was not stabbed. LEAMAN said that he may have said that he was stabbed but he was mistaken. He said that between GALLO yelling and talking to dispatch he may have become confused.</p> <p>LEAMAN said that the argument was over money that LEAMAN is holding for GALLO. LEAMAN said that GALLO's money is in his bank account. GALLO has already taken out the daily maximum out of the account so the ATM will not give him any further withdrawals. GALLO believed that LEAMAN was trying to steal the money from him.</p> <p>SUB/JAMES COOK was sitting in the living room during the argument. The argument took place in the bedroom in the back of the house. In running COOK he has a warrant for his arrest out of GOV/NORTH ROYALTON PD for contempt of court. He owes fees for a past traffic offense. The warrant was confirmed by Disp Laub. COOK was transported to the BP at W150th and I-71 where he was turned over to unit #77.</p> <p>In running GALLO he has warrants for his arrest out Lakewood and Fairview Park for fines owed from prior offenses.</p>
