Topic Original Report

MO: by entering victims apartment and taking victims jewelry and camera without permission.

On 3/19/08, at 2138 hrs., I was detailed to 12050 Lake #307 on a complaint from VIC/TERRELL HOWARD stating some of his property was stolen. enroute to the scene, dispatch advised me that PTL. PIETCH was at the apartment today at 1632 hrs. on a call from HOWARD'S girlfriend, OIV/LATASHA STILWELL, regarding the same thing. At that time, STILWELL was advised to have HOWARD call LPD when he arrived home because it was his property that was missing. Dispatch also advised me that the Lakewood animal warden was at HOWARD'S apartment today at 1234 hrs. and removed a dog and a cat see cad #080790067 for further details.

On arrival, I spoke with HOWARD and STILWELL and learned that they believe that OIV/MARK TOROWSKI and MICHAEL COOK took the listed property. HOWARD advised that the camera and gold chain were in the desk drawer in the bedroom. I further learned that HOWARD and STILWELL are in the process of being evicted. HOWARD and STILWELL said they suspected COOK and TOROWSKI because they were in the apartment to do an inspection today without HOWARD'S permission. HOWARD stated he has had problems with COOK since he moved in almost a year ago. I asked HOWARD what kind of problems and he stated he thinks COOK is a racist. It should be noted the apartment contained many other small electronics including Ipods and portable dvd players that could have easily been taken, but were not.

I spoke with TOROWSKI, who is the on site building manager. TOROWSKI advised that he has had numerous complaints from other tenants about a dog in HOWARD'S apartment. TOROWSKI said that was one of the reasons HOWARD was being evicted. TOROWSKI stated he put a 24 hr. notice under HOWARD'S door, advising him that the management company was going to inspect his apartment on 3/19/08. TOROWSKI gave me a copy of the notice. TOROWSKI further advised that he and COOK entered HOWARD'S apartment to do their inspection at around 1215 hrs. TOROWSKI said he opened the bathroom door and found a dog and cat inside. The dog's mouth was duct taped shut and it's paws were bound together. TOROWSKI and COOK left the apartment and COOK called LPD.

TOROWSKI stated they waited out in the hallway until the animal warden arrived. They again entered the apartment with the animal warden. TOROWSKI said after the Animal Warden left they locked HOWARD'S apartment and left. TOROWSKI stated that neither himself nor COOK went into HOWARD'S bedroom.

I returned to HOWARD'S apartment to speak further with him. I asked HOWARD about the dog and he stated that COOK and TOROWSKI must have duct taped the dog. I showed HOWARD the 24 hr. inspection notice and he said he never got one. I advised HOWARD of the consequences of making a false police report and he advised he understood. INV. REGISTER arrived and processed the desk in the bedroom but found nothing of value.

STILWELL and TOROWSKI do not have a CCH. HOWARD has a CCH BCI# for child endangering. COOK has a CCH BCI# and FBI# for simple assault, drug abuse, coercion, receiving stolen property, carrying a concealed weapon, and ovi.
