Topic Original Report

M.O. By punching the victim in the face several times and kicking him while on the ground causing the victim physical harm.

On 3-19-08, I was on patrol southbound on Cove Avenue. As I was approaching the railroad tracks, I was waved down by a male who was bleeding from his forehead. In speaking with this male, he was identified as VIC/LAWRENCE WILLIAMSON.

It should be noted that P.O. GREEAR and I were on a detail at his residence 10 minutes prior to this incident for a male who was on the street looking for something. WILLIAMSON was outside his apartment looking for his keys that he stated he lost. Officers could not locate his keys and WILLIAMSON stated he was going to stay at his sister's house.

In speaking with WILLIAMSON about the Assault, he related the following. WILLIAMSON stated he was looking for his keys outside his residence at Cove. He walked to speak to a male and female who were standing in front of 1277 Cove. WILLIAMSON stated he bought one cigarette from this male. WILLIAMSON stated the male began yelling at WILLIAMSON and accused him of insulting his girlfriend. WILLIAMSON stated he did not insult this female and began to walk across the street. WILLIAMSON stated that the male began punching him in the face and was kicking him after he fell to the ground. WILLIAMSON stated the male and female then ran eastbound on the railroad tracks from Cove Avenue. Officers checked the area but were not able to locate the suspect.

WILLIAMSON described the suspect as a white male in his late twenties. WILLIAMSON stated the male was wearing a brown jacket, black jeans, and black boots. WILLIAMSON described this male as 6'2" and approximately 210 pounds. WILLIAMSON stated he has never seen this male before. He could provide no description of the SUS's girlfriend.

WILLIAMSON was transported to Lakewood Hospital for his injuries by LFD Squad 3. WILLIAMSON was treated by Dr. GABRIN. WILLIAMSON received 4 stitches above his left eyebrow and was treated for bruised ribs.

INV. PICKENS responded to the ER to take photos of WILLIAMSON'S injuries.

I obtained a statement from WILLIAMSON and he also signed a Release of Medical Information Form.

WILLIAMSON stated he desires prosecution in this matter. He was also advised of the solvability regarding this matter.
