Topic Original Report

M.O. 1: By punching victim in the head.

M.O. 2: By jumping on the hood of victim's vehicle and kicking the windshield, causing damage thereto.

Lt. Warner, Sir:

On 03/19/2008, at 2011 hours, I was dispatched to 1377 Gladys Ave., Municipal Lot 10, on the report of a male being punched. On arrival, I met COM/JESSICA L. WHITMAN, VIC/DOMINIQUE T. WILLIAMS and VIC/JOSHUA S. TAYLOR. WILLIAMS advised that he, WHITMAN, and TAYLOR arrived at the Phoenix Coffee Shop, 15108 Detroit Ave., at approximately 2000 hours, on 03/19/2008.

Soon after they walked in, SUS/KYLE A. MCCLELLAND walked up to a microphone at the coffee shop and announced that WILLIAMS was a rapist and was "in the house". Upset by this, WHITMAN, TAYLOR, and WILLIAMS started to leave. Before they could leave, however, MCCLELLAND walked up to WILLIAMS and punched WILLIAMS on the right temple of his head.

WHITMAN, TAYLOR, and WILLIAMS then quickly exited the coffee shop, and got into the indexed vehicle in the Municipal Lot 10. The vehicle is owned by WHITMAN's step-father, VIC/SKIP W. STONE. Once in the vehicle, MCCLELLAND, who had followed them from the coffee shop, jumped onto the hood of the vehicle. MCCLELLAND then kicked the windshield, breaking the glass and causing the middle portion of the windshield to cave in. MCCLELLAND then jumped down from the hood and walked away, headed northbound on Gladys Ave. WHITMAN then called LPD.

On our arrival, WILLIAMS advised that the right side of his head was hurting and painful to the touch. I was unable to see any visible injuries to his head or otherwise.

Officers searched the area, as well as MCCLELLAND's listed address, but were unable to locate him. Inv. Mladek arrived and processed the scene for evidentiary purposes.

WILLIAMS explained that MCCLELLAND has been angry with him for a while, stemming from when WILLIAMS "hooked up" with MCCLELLAND's then-girlfriend approximately one year ago. WILLIAMS also indicated that MCCLELLAND has never attacked him prior to this incident.

I spoke with WIT/MATTHEW J. O'REILLY, who was working at the Phoenix Coffee Shop during this incident. O'REILLY indicated that he saw MCCLELLAND approach the microphone, and heard MCCLELLAND announce that WILLIAMS was a rapist. Then, according to O'REILLY, MCCLELLAND walked over to WILLIAMS and punched WILLIAMS in the head. O'REILLY added that after WILLIAMS, WHITMAN, and TAYLOR left, MCCLELLAND apologized to O'REILLY for the disturbance, then left the coffee shop himself. O'REILLY indicated that he knows MCCLELLAND because MCCLELLAND comes into the coffee shop every couple of days.

WILLIAMS desires prosecution in this matter. I attempted to call STONE, but was unable to reach him. WHITMAN explained that while the vehicle belongs to STONE, she is the only driver of the vehicle. As such, WHITMAN also desires prosecution.
