N A R R A T I V E	1	<p>Topic Original Report</p> <p>M.O.: By kicking in the victim's door, entering the residence, and pointing a gun at the victim ordering him to get on the ground.</p> <p>On 3-21-08, at 2235 hrs, Officers responded to the area of 2000 Morrison Apt #5. VIC/KEVIN SKELLY indicated an unknown male wearing a mask had kicked in his door and pointed a gun at him. The suspect was a white male, short in stature, and was wearing all dark clothing. When I arrived on scene I spoke with SKELLY and learned the following:</p> <p>SKELLY stated he was sitting on his couch when an unknown male knocked on his door. He indicated he was not expecting anyone at this hour and asked who it was. SKELLY was unable to understand what the male said, but stated he thought the male mumbled the name Gary. SKELLY told the male through the door he was at the wrong apartment. Shortly after saying this, SKELLY stated someone started to kick his door. SKELLY stated he grabbed a pocket knife that was on the coffee table and stood up. The male kicked the door open and entered. The male pointed a chrome gun at SKELLY and told him to "get on the fucking ground". SKELLY stated he immediately ran through the kitchen out the back door. The suspect followed SKELLY into the kitchen, but stopped as SKELLY ran outside. SKELLY stated he observed the male turn around and walk back through the family room. SKELLY found a neighbor and contacted the police immediately.</p> <p>The suspect was a white male, approximately 5'6". He was dressed in black, and was wearing a mask. SKELLY also believes the male may have been wearing gloves. The only visible part of the male was around his eyes. SKELLY stated he is not familiar with guns and was not sure what type it may have been. The only thing he could tell me was it was chrome.</p> <p>SKELLY did not believe anything was taken from his home, and has no suspects. Inv. Register took photo's of the damaged door, and nothing of evidentiary value was found.</p>
