Topic Original Report

MO1: By entering the residence at 2229/2231 Wyandotte Ave. by unknown means and taking the copper piping from the basement.

LT. SPRAGUE, Sir:

On 3-21-08 at 1143 hrs. officers were detailed to 2229 Wyandotte Ave. on the report of the copper piping having been stolen from the house.

On arrival I spoke with VIC/LARRY GEORGE. LARRY stated that he is the owner of 2229/2231 Wyandotte Ave. and both residences in the house are vacant. LARRY added that he has been remodeling both the residences while vacant. On 3-20-08 LARRY stated that he arrived at the property at 1000 hrs. and was there until 2100 hrs. Prior to leaving, LARRY stated that he locked and dead bolted the main front door and exited out the main rear door locking it as he left. LARRY advised that he did not lock the doors to the up and down residences off the front and rear hallways. LARRY stated that he returned this morning at 1000 hrs. and found the storm door to the main rear door propped open and rear door open. Upon checking the rest of the house, the main front door was also found to be unlocked and open. LARRY did not find anything disturbed in either the up or down residences, however, all of the copper piping had been cut out of the basement and removed. LARRY then called LPD.

The piping appeared to have been cut with some sort of tin snips as the remaining edges of the pipes were pinched in. There were no signs of damage on the pipes in the two residences and they were still intact.

In further checking the house, there were no signs of forced entry. All the windows in the house are newer replacement windows and were all locked and undamaged. LARRY stated that he had locked the doors prior to leaving on 3-20-08, and there were no signs of forced entry on either of the doors.

I asked LARRY who his previous tenants have been and when did they move out. LARRY stated that the downstairs, 2229, has been vacant for a long time. However, LARRY advised that he had evicted the upstairs residents from 2231 in February. I asked LARRY if he got all of the keys back from his prior tenants and he stated "I think so." LARRY further advised that the prior tenants in 2231 were OIV/JANICE GEORGE and OIV/AL GEORGE. Neither are any relation to LARRY. LARRY is unsure where they moved to after they left his property.

INV. MOHER #72 arrived on scene and photographed the damage. No latents were obtained.

I spoke with OIV/KAREN KURAMOTO at 2227 Wyandotte Ave. KURAMOTO stated that on 3-21-08 at about 0130 hrs. she saw a black car with a loud muffler park in front of 2229/2231 Wyandotte Ave. At about 0230 hrs., KURAMOTO stated she saw a white male wearing dark clothes picking up a couple duffel bags and bundles wrapped in cloth and place them inside the black car. KURAMOTO advised that after the male loaded the items in the vehicle, he drove north on Wyandotte Ave., then turned around and drove back south. She last saw the vehicle head west on Lakewood Hts. Blvd. KURAMOTO described the male as being about 6' tall and in his mid-20s. She stated that she did not get a good look at him and only saw him when he passed under a street light. When asked why she

did not call LPD regarding the male, KURAMOTO stated that she thought the male may have been moving out of 2228/2230 Wyandotte Ave. She added that several of the past residents have moved out in the middle of the night.

INV. MOHER and I attempted to contact the residents at 2228/2230 Wyandotte Ave. From the front porch, officers could see that the first floor residence was vacant. The side door to the residence was found unlocked. Officers entered the house and immediately checked the basement. The copper piping was still intact. In checking the upstairs residence, the rear door off the common rear stairwell was found to be open. The residence appeared to be occupied, but no one responded to repeated calls from officers. The rear door of the residence was closed by officers prior to leaving.

LARRY stated that he did not have any suspects at this time, but prosecution is desired. LARRY was advised of solvability factors and advised to change the locks on his property.

It should be noted that AL GEORGE has a CCH with a BCI number of [REDACTED] and FBI number of [REDACTED] and an LPD number of [REDACTED]. Additionally, he has a warrant out of LPD for CONTEMPT OF COURT on an original charge of POSSESSION OF MARIJUANA.
