N A R R A T I V E  1	<p><b>Topic</b> Original Report</p> <p>M.O.:By entering the victim's unoccupied house without permission.</p> <p>On 3/25/08 at 1642 hrs. Inv. Walling, Ptl. Beno, and I responded to 1271 Idlewood Ave. on an anonymous report that a male just entered an uninhabited house at that address.</p> <p>On arrival Inv. Walling began to search the house and discovered a male hiding in the attic. Inv. Walling and Ptl. Beno handcuffed the male, who identified himself as ARA/BRANDON THOMAS. THOMAS said he was in the house because he thought he left some items in the house. When we asked him how he left the items there, he said he thought he left them prior to his last arrest at the house. THOMAS said he was arrested at the house in the past for Breaking and Entering. I told THOMAS he was again under arrest for Breaking and Entering.</p> <p>I secured THOMAS in my vehicle and explained the Miranda warnings to him. He said he understood them and would speak with me. I asked THOMAS when he entered the house. He said he went inside just prior to our arrival. I asked THOMAS how he opened the door of the house. He explained that the door along the driveway, on the south side of the house, was unlocked and he just walked in. When I asked THOMAS what he was doing in the attic, he said he walked up there when he saw officers arrive because he wanted to enjoy his last few minutes of freedom.</p> <p>I transported THOMAS to LPD and booked him with C.O. Bunner.</p> <p>THOMAS had past arrests for Burglary, Receiving Stolen Property, Unauthorized Use of a Motor Vehicle, and Obstructing Official Business. His BCI number was c298197, his FBI number was 223821KC8, and his Ident. number was 22102.</p> <p>Dispatch contacted the company that owned the house, VIC/INSOURCE FINANCIAL SERVICES. Dispatch obtained the name of OIV/PAT NEALON, who was the contact person at the company for 1271 Idlewood Ave. I later spoke with NEALON. He said the company desired prosecution for the incident. I did not initially get all of NEALON's MIN info and on call back I got his voice mail.</p> <p>See report 07009856 for details of THOMAS's previous arrest at 1271 Idlewood Ave.</p>
