	<p>M.O. By entering a banking institution with a butcher knife, jumping over counter and taking \$2,541.42 in US currency without permission</p> <p>On 3-25-08, at 1402 hours, cars were detailed to VIC/DOLLAR BANK, 15509 Madison, on report of a hold up alarm in the bank. As cars were responding, dispatch advised that it was a good alarm and that the suspect left using the rear door of the bank. The initial description given was a w/m wearing a beige coat, blue jeans, a black hooded sweatshirt, and a black ski mask. As officers were first responding to the scene, employees at the bank believed the suspect had left east out of the back doors.</p> <p>While approaching the bank, five \$5.00 bills were located by Ptl. Robinson near the west side of the bank toward the rear fence line. A blue baseball cap was located in the rear parking lot of 2011 Lakeland by this officer. The baseball cap was not initially believed to be worn by the suspect due to the descriptions received from the bank employees and witnesses but was later identified in surveillance video as the baseball cap that the suspect was wearing. Surveillance video showed the suspect was wearing the black ski mask as well as the blue baseball cap. Officers checked the area</p>

for the suspect with negative results.

Upon speaking with VIC/BARBARA BRYANT, I found that she was the teller that was approached by the suspect. BRYANT was working at teller booth #4, which is the most southern booth. She was waiting on VIC/DEBORAH NOWAK when she noticed a male walking quickly toward her. BRYANT observed the suspect push NOWAK out of the way and then jump onto the counter. BRYANT described the suspect as a w/m, blond hair, 5'11, medium build, beige coat, black hooded sweatshirt, blue jeans and a black ski mask.

The suspect told BRYANT to move out of his way, and he first reached to the right side of the counter. The suspect then opened a drawer on the left side of the counter where the money was kept. The suspect began grabbing the money out of the drawer with his right hand and putting it in a bag that he had in his left hand. He did all of this while still sitting on the counter. The suspect initially sat on the counter with his feet facing the lobby and then turned around so his feet were facing BRYANT. It did not take the suspect very long to clear out the drawer and then he ran out of the rear door to the bank.

After the suspect left the building, BRYANT noticed a large butcher knife near her feet on the floor just below the money drawer. BRYANT advised the suspect never brandished the knife but must have dropped it when he jumped over the counter. BRYANT was not injured.

Upon speaking to NOWAK, she advised that she was standing at the counter talking to BRYANT when she heard a male say, "excuse me ma'am". NOWAK then felt the suspect come from her right side and push her out of the way with his body. NOWAK stumbled back several feet, but did not fall to the ground. NOWAK realized that the male was robbing the bank and she ran into one of the cubicle work stations directly behind her. NOWAK ran into the cubicle where OIV/JOHN PHILLIPS was working. NOWAK remembers the male was wearing a black ski mask, had a black hood on, and was approximately 5'10 or 5'11 in height. NOWAK was not injured and declined medical attention.

OIV/AMANDA GREEN AND OIV/ALAN SALAMON were working behind the counter during the incident.

Behind the counter, where BRYANT was working were also several bills that the suspect dropped. There were seven \$50.00 bills left on the counter, one \$10.00 bill and one \$20.00 bill lying on the floor. At the time of this report, DOLLAR BANK security officials were working on sending surveillance video of the suspect to Det. Fritsch.

The knife, seven \$50.00 bills, one \$10.00 bill, one \$20.00 bill, five \$5.00 bills, and blue baseball cap were photographed, processed and confiscated by Inv. Kulczycki. See his supplement for additional information and the listing of those items.

After the drawer was counted, the bank advised the suspect got away with \$2,541.42 in miscellaneous US currency. There were no dye packs taken, but he did take bait money.

The bank provided a list of the bait money that included serial numbers.

The bait money was entered into LEADS as stolen by Dispatcher Lewandowski.
