Topic Original Report

Sgt. L. WILKINS;

On 3/26/08, around 2010 hrs., COM/PAUL MENCKE came to the front counter of the police department to report that he had been assaulted earlier in the day by his [REDACTED] SUB [REDACTED]

PAUL advised that around 1745 hrs., he got off work and went to his ex wife's, OIV/YVONNE MENCKE [REDACTED] YVONNE came outside complaining that [REDACTED] was not home. YVONNE advised PAUL that [REDACTED] is currently grounded for not listening at home, coming home late and possibly drinking alcohol and using drugs. YVONNE advised she called [REDACTED] on his cellular phone and [REDACTED] told her [REDACTED] was with friends and [REDACTED] wasn't coming home. YVONNE asked PAUL if he could find [REDACTED] and advise [REDACTED] to come home. YVONNE advised PAUL that she believed [REDACTED] was possibly on Cohasset because [REDACTED] has friends that live around there.

PAUL advised he started to check the area and found [REDACTED] walking into Madison Park, 13201 Madison Avenue. PAUL advised [REDACTED] pulled into the park and stopped [REDACTED] [REDACTED] advised PAUL that [REDACTED] was not going [REDACTED] PAUL stated that it appeared [REDACTED] was about to run from him so he grabbed [REDACTED] sweatshirt. [REDACTED] started to punch PAUL in the face several times. PAUL advised he took [REDACTED] to the ground to try and calm down. PAUL advised [REDACTED] continued to punch PAUL. On a couple occasions, [REDACTED] was able to knock PAUL off of [REDACTED] but [REDACTED] kicked PAUL in the head. Eventually PAUL was able to get [REDACTED] back on the ground. PAUL advised that while he was holding [REDACTED] down, he never punched [REDACTED] and only slapped [REDACTED] in an attempt to calm [REDACTED] down. PAUL advised that after [REDACTED] wrapped [REDACTED] legs around him, PAUL let [REDACTED] go. [REDACTED] took off running. See his statement for details.

PAUL had a small scratch to his upper lip, his left cheek was red and he advised that his right hip was sore. PAUL declined any medical attention. Inv ALLEN arrived and took photos of PAUL. PAUL advised shortly after this happened he called LPD and spoke to Officer HERPKA for advice on what he should do. He spoke YVONNE about the incident and she accused him of starting the fight even though she wanted him to go find their son.

PAUL was asked if he desired prosecution for Domestic Violence. PAUL advised that he didn't think that he would pursue anything criminal and was more interested in documenting the incident in case YVONNE went to the police as well. PAUL also said that he didn't want [REDACTED] to have an arrest record or the possibility of [REDACTED] going to the Detention Center. It should be noted that at the time of this report, PAUL was not sure if [REDACTED] had returned to [REDACTED] mother's [REDACTED] and YVONNE hadn't reported [REDACTED] missing to LPD.

PAUL advised that the altercation happened in the grass area of the park between the north parking lot and the swimming pool. It is not known if the security camera from the park recorded the fight.
