Topic Original Report

MO #1-By being voluntarily intoxicated and a risk of harm to herself or others.
MO #2-By kicking a uniformed Dispatcher while she was acting in her work duties.

Detailed on 3-29-08 at about 1631 Hrs. to the area of The Shamrock Tavern (11922 Madison Ave.) on the report of an intoxicated female walking down Madison drinking beer she had hidden inside her waistband. On arrival Inv. Kulczycki and I were directed by COM/VANESSA BROOKS E/B on Madison towards W. 117th St. BROOKS stated that she was now walking in and out of traffic. The female, later identified as ARA/MAUREEN NOONAN, was observed doing so on Madison just west of Coutant Ave.


In observing NOONAN, she was found to have a strong odor of an alcoholic beverage about her person. NOONAN also had heavily slurred speech, glassy bloodshot eyes and was unsteady on her feet. NOONAN was highly agitated about an undetermined matter. NOONAN was then advised she was under arrest for DCI and secured. NOONAN was then placed in the rear of car 203 for transport to Lakewood Jail.

It should be noted once NOONAN was arrested, she directed her anger towards Officers. NOONAN repeatedly referred to Inv. Kulczycki and I as "bitches" and that she would "kick our ass" once she got into the Jail. NOONAN bragged "I've been in prison" and that she was from "Detroit" so we better watch out. Seeing how changeable NOONAN's demeanor was Inv. Kulczycki also responded to the Jail to assist with booking.

At LPD, NOONAN was booked into Jail by CO McCarthy, VIC/DISP. FLORJANCIC, Inv. Kulczycki and I. Sgt. Spaetzel also observed the booking from beside CO McCarthy. NOONAN was still changeable in her demeanor as the initial booking questions were asked. NOONAN was unresponsive or would not answer several of them. NOONAN continued to be hostile towards this Officer and threatened to "kick you in the balls". As this continued for a short time Sgt. Spaetzel directed Officers to change NOONAN over and she could complete the booking after she had begun to sober up and prior to her release on citation #M39978 for DCI.

After FLORJANCIC finished her search of NOONAN she advised her that she would have to be changed over into jail clothing prior to being placed in the cell block. NOONAN then began to direct her anger at FLORJANCIC. FLORJANCIC then asked NOONAN to take off her shoes. As NOONAN began to do so, she kicked FLORJANCIC across her left shin/knee area and ended the kick at the right side of her right knee. FLORJANCIC attempted to get out of the way but could not due to the speed of NOONAN's actions. NOONAN was then spun around facing the cage at the booking window and she removed her shoes. NOONAN continued to be uncooperative and was eventually placed in the restraint chair.

In speaking with FLORJANCIC, she stated she was in a little pain. Red marks were clearly observed on both areas of impact and some bruising had already begun. Inv. Kulczycki then took photos of FLORJANCIC's injury. See his photo sheet for detail. FLORJANCIC initially refused medical treatment but stated that she does desire prosecution in this matter. After the matter was discussed with Sgt. Spaetzel, it was determined that NOONAN would be charged with Assault (M), Ohio Revised Code. Citation #M39979 was also issued to NOONAN for Assault. NOONAN was eventually placed into the female cell block and advised on her court date.
