N A R R A T I V E 1	Topic Original Report M.O. - By breaking out both the rear storm and basement door window to gain entry into the vacant house and removing copper pipe from basement without permission. On 3-31-08, at approximately 1937 hrs., I was detailed to 1669 Bunts Road to speak to VIC/EDWARD J SATTERFIELD about some copper pipe that had been taken out of his basement. Upon arrival, I spoke with SATTERFIELD and learned the following: SATTERFIELD is the owner of the residence at 1669 Bunts Road, but the property has been vacant since November of 2007. SATTERFIELD stated that he frequently stops by the residence to check the property and was last there on 3-26-08, at approximately 1900 hrs. At that time, everything was fine with the property and all was intact. When SATTERFIELD returned to the residence on 3-31-08, at approximately 1930 hrs., he found that the rear door of the residence was open. Both the glass from the basement door and the outer storm door had been broken out to gain entry. Upon checking the residence, SATTERFIELD only found some copper pipe to be missing from the basement and nothing else was disturbed. There appeared to be approximately 30 ft. of copper pipe missing from the basement. The suspect(s) had cut the pipe from the main water line, the basement bathroom and the utility sink area of the basement. No other damage appeared to be done and nothing else was missing. SATTERFIELD stated that he has no suspects in this matter and was advised of the solvability factors. Inv. ALLEN responded to the scene for photos. Nothing else of evidentiary value was located. After speaking with SATTERFIELD, I attempted to speak to the neighbors in the area to see if anyone had seen or heard anything suspicious. The only person home at the time was MICHAEL MCNEES at 1671 Bunts Road. Upon speaking with MCNEES, he stated that he did not hear or see anything unusual during the week and was not able to provide any further information. SATTERFIELD advised that prosecution is desired in this matter should any suspects be located. It should be noted that on 3-29-08, a similar report was taken at 1661 Bunts Road.
