Topic Original Report

M.O.: By forcing open the door to the VIC's apartment and leaving with the VIC's property without consent or permission.

LT. Warner, sir:

On 4/1/2008, at 1846 hours, I was dispatched to 1114 Cook on a call from VIC/JEAN MILLER stating her apartment had been broken into and items taken.

Upon arrival, I spoke to MILLER, who stated the following: MILLER left her apartment for work this morning at approximately 0715 hours. When MILLER returned home at approximately 1820 hours she discovered the door to her apartment had been forced open and her television was missing. MILLER contacted Lakewood PD and then her landlord. MILLER checked her apartment and found that other items were also missing.

1114 Cook is the east entrance to the apartment building located at 14901 Lake. MILLER's apartment is the only apartment on the ground floor inside the Cook entrance. MILLER's apartment front door had been forced open, splintering the door frame. Pieces of the door frame covered the floor inside the entrance to the apartment. The back door was locked from the inside. The back door leads to a common courtyard with stair access to every apartment in the building.

Inside the apartment to the north is the family room. The listed Sanyo television was missing from its stand in the northwest corner. The family room features a large closet on the east wall. This closet had been opened and rummaged through. MILLER kept her luggage set in this closet. This matching luggage set included a large suitcase, a smaller carry-on with wheels, and a garment bag. MILLER kept the carry-on and garment bag inside the large suitcase. The carry-on and the garment bag were now in the middle of the family room floor, and the large suitcase was missing.

In the bedroom, MILLER's dresser drawers had been rummaged through. A brown leather case containing miscellaneous coins was missing from the top left drawer. MILLER kept wheat pennies, silver dollars, and foreign currency in this case. On top of the drawers sits a jewelry box. The listed three rings, two bracelets and necklace were missing from the jewelry box.

Inv Fioritto arrived to photograph the scene. Nothing further of evidentiary value was found.

I spoke to MILLER's landlord, OIV/TIMOTHY MCNEELY, and Building Manager OIV/ANDREW WALLACE, who stated the following: Today at approximately 1230 hours, MCNEELY and WALLACE were driving back to 1114 Cook after lunch. As they turned northbound onto Cook from westbound Clifton, they observed a B/M carrying a black backpack and a large suitcase. They described this male as older, 40 to 50 years old, medium build, and tall, approximately 6'2". The male was wearing a dark colored jacket, a dark colored hat, and possibly work pants such as Carharts. This male walked south, crossing Clifton.

MCNEELY and WALLACE stated the suitcase that was carried by the SUS matched MILLER's carry-on and garment bag.
