MO: By putting stacked chairs under the kitchen window to gain entry to the residence through the window and remove numerous items from he residence without permission.

4-3-08, Detailed to 1430 Gridley on report that the house was broken into and numerous items were taken. Upon arrival, spoke to VIC/ SONYA JONES and her boyfriend, VIC/ DAVID NESBIT. NESBIT stated that when he came home from work he found that several items that had been on the kitchen window sill were on the back patio. He stated that he then found that the screen for the kitchen window was leaning up against the house and the window was wide open. He then found that the rear door was wide open.

NESBIT stated that upon entering the house he found that several of his items were missing from the living room and he then called JONES, who responded home. JONES stated that she went to her son's bedroom in the basement and found that it had been ransacked and numerous items were missing. JONES called her son, VIC/ \_\_\_\_\_, who arrived shortly after us.

Upon checking the area, we found that the suspect(s) had moved a stack of plastic patio furniture underneath the kitchen window to push open the window to gain entry. JONES stated that she thought the window had been locked but I found that it had to be pushed down very hard in order for the locks to catch, so it probably was not secured. The screen had been bent to be removed and the suspect moved several items from the window sill and put them on the patio so that they could crawl in.

Once inside the residence, the suspects removed a Playstation 3 and several PS3 video games and Blue Ray movies that had been stacked to the right of the television. These items belonged to NESBIT. It should be noted that a large, LCD, flat screen T.V. and surround sound system was not disturbed.

The next target was the master bedroom at the top of the steps on the second floor. In this room was another large, flat screen, LCD T.V. The only thing missing from here was a glass Tequila bottle that was filled with coins. The label on the bottle was Tequila Reserve 1800 which was taken from a shelf on the west wall.

The main target was found to \_\_\_\_\_'s bedroom that was in the basement. At the bottom of the basement steps was a sheet that was hung over the entry was so one would not be able to see what was in the basement. In the basement was a futon, dresser and an entertainment stand. From the entertainment stand, several items were taken such as: a 32 inch LCD flat screen T.V., Direct TV receiver, and a X-box 360 game console. All of the dresser drawers were wide open, but nothing was missing. Numerous X-box 360 games and DVDs were missing and from a plastic storage tote next to the entertainment center. Three sets of headphones and two hard drives for the X-box 360 were also missing.

\_\_\_\_\_ stated, "it must be my friends". He stated that he was friends with SUS/ \_\_\_\_\_, SUS/ JAMES WALSH, SUS/ \_\_\_\_\_ and SUS/ \_\_\_\_\_

The friendship ended in mid March when they were bragging about breaking into several Lakewood houses. \_\_\_\_\_ had stated that \_\_\_\_\_ was spoiled because of all of the things that he had.

After the ET work was finished, Inv. Kulczycki and I canvassed the area. We found that JONES had

spoken with several neighbors on her street who stated that they did not see anything. The backyard is fenced in by a chain link fence and the gate was near the house. We found a power cord to one of the games in the backyard, near the garage. At the corner of the back of the garage we found the listed glass water bong. There was a path that went behind the garage and over a small wire fence to the rear of the garage at 1431 Rio. It was found that this residence was vacant.

We were able to find the resident at 1412 Rio home. After speaking with WIT/ GENIE KOEHLER, she advised that she was home and not feeling well due to a back injury and she went back to bed around 1030 hrs. At that time she looked out her bedroom window and saw a w/m, approx 16-20 yrs wearing a dark jacket and dark stocking cap. The male was walking back and forth by the garage at JONES' house and was carrying something, however she could not see what he was carrying. As he got to the rear of the garage she lost sight of him until he walked towards the house again. She invited Inv. Kulczycki and I to look out her bedroom window to see what she was talking about. From this window there was an unobstructed view of the north side of JONES' garage. KOEHLER stated that she didn't think much of it until she saw the police over at the house.

While working on this report, JONES called me and advised that she and her son went to residence and spoke with his mother. JONES told her what had happened at her house and asked if \_\_\_\_\_ was at home all day. She stated that \_\_\_\_\_ was home all night and all morning. As JONES was walking over to WALSH's residence she saw \_\_\_\_\_ mother make a call on her cell phone.

JONES that she spoke to WALSH's father who stated that \_\_\_\_\_ mother was lying for her son. He stated that \_\_\_\_\_ had stayed at his house the past two nights because he told him that his mother kicked him out. JONES stated that Walsh's father stated that his son JAMES and \_\_\_\_\_ were gone all morning. He told her that he would look for the items and call her if they are located.

Inv. Kulczycki responded for ET. The water bong was later tagged and placed into secured storage.

Ofc. Mance and I responded to 1639 Northland to speak with WALSH. Upon arrival, we could hear WALSH yelling at someone. When we knocked on the door, WALSH's father answered the door and invited us in. WALSH's first comment was to yell at us saying that he didn't do anything and to take his fingerprints. He later calmed down but would not make eye contact. He stated that he and \_\_\_\_\_ left his house at 1100 hrs and walked to a friend of his who lives on Dowd. He stated that he was sure that it was 1100 hrs because he did not get up until 1030 hrs. He stated that they were at his friend's house until 1815 hrs and then walked home.

WALSH stated that his friend's name is ANNA, and he did not know what her last name was. He stated that she lives on Dowd with her husband, and they don't have a phone and he did not know the address. When asked what they did all day, he stated that they hung out and then went to LHS and watched as ANNA's husband ran the steps in the bleachers, and then they went back to ANNA's house and walked home from there. He stated that \_\_\_\_\_ did not stay over but has in the past. He stated that the only person he would know of that might have broken into the house was OIV/ MIKE ZAHURAK. He stated that ZAHURAK brags all of the time about breaking into houses and taking video games. He stated that he does not know where ZAHURAK lives but knows that he did a break into a residence on Cannon, which was WALSH's friend's house.

WALSH's father stated that he works midnight shift and when he came home he looked into the spare bedroom through the slightly ajar door and thought that he saw \_\_\_\_\_ sleeping in the bed but could not be certain it was him. He did look into WALSH's room and saw him sleeping there. He stated that he checked the house and did not locate any stolen property.

We then went to 1598 Northland and spoke with \_\_\_\_\_ and his mother SUB/ SHARON/ STENROOS. SHARON stated that \_\_\_\_\_ was home all day and did not leave the house until 1330 hrs. She did say that she had to run some errands but he was there when she left and until she returned home. She stated that \_\_\_\_\_ has never spent the night at Walsh's house.

I spoke to \_\_\_\_\_ separate from his mother and he too stated that he did not leave his house until 1330 hrs. He stated that he went with WALSH to a friend's house in Birdtown but did not know the street. He stated that they were there with ANNA and her husband and went to LHS with the husband. He denied committing the burglary and stated that he was good friends with \_\_\_\_\_ up until two weeks ago where the friendship ended due to \_\_\_\_\_ owing \_\_\_\_\_ ten dollars. When asked who he would think did it, he too named ZAHURIK.

At that time SHARON was placed under arrest for an outstanding Lakewood traffic warrant. She was transported to the station where she posted bond at the front counter.
