Topic Original Report

- MO1: By being in possession of Suboxone 8mg/2mg, a schedule III drug, without prescription.
- MO2: By passing a counterfeit \$50.00 at 11790 Madison Ave., Burger King, for beverages.
- MO3: By climbing out a bedroom window in an attempt to avoid arrest.
- MO4: By stating to police that no one else is in the apartment while two other parties were in the apartment, hindering an investigation.
- MO5: By being in possession of a hypodermic needle.
- MO6: By being in possession of crack pipes, chore boy, and razor blades with residue on them.
- MO7: By being in possession of a 3.75" folding blade knife while being taken into custody.
- MO8: By residing in a residence and knowingly allowing illegal drug use to take place in residence.

SGT. WILKINS, Sir:

On 4-6-08, while conducting a CRIMINAL SIMULATION investigation, it was learned that one of the suspects resides at 2026 Lark St. #2.

On arrival myself, P.O. REBRACA #9, and P.O. WINTRICK #40 went to the front door of the apartment. P.O. LOWTHER #32 and P.O. ZBYDNOWSKI #34 went to the rear of the building. I knocked on the door and a male asked "who is it?" I responded the police. He did not answer the door, so I knocked again. Again a male asked "who is it"? Again I responded the police. This went on several more times until the male, later identified as ARA/JERRY WALKER, answered the door. WALKER opened the door slightly and spoke through the cracked door. I asked WALKER if "TONY" was there and WALKER stated "no". I asked WALKER if anyone else was in the apartment and WALKER stated "no". I asked WALKER if I could come in and speak with him. He stated we could talk through the door. I asked WALKER who resides in the apartment and he stated that he lives there with his girlfriend. As I was speaking with WALKER, P.O. ZBYDNOWSKI radioed that a male was crawling out a rear window. I asked WALKER who was crawling out the window and who else was in the apartment, WALKER opened the door and let officers in the apartment. As officers entered the apartment, ARA/REBECCA MITCHELL came out from one of the back bedrooms. She and WALKER were told to stand in the kitchen with P.O. REBRACA. P.O. ZBYDNOWSKI then radioed that the male who had crawled out the window was secured and identified as ARA/ANZEL HARNESS. I asked WALKER again if anyone else was in the apartment. He stated no and that officers could check. Myself and P.O. WINTRICK checked the apartment for any other parties.

No other parties were located in the apartment. However, on top of a DVD case on the coffee table in the living room was the listed razor blade with residue on it in plain view. On the bottom of the coffee table, also in plain view, were found a crack pipe, a hypodermic needle, a cell phone, chore boy, and a baggie of an unknown white powder with a razor blade inside the baggie.

The first bedroom was the room in which HARNESS crawled out the window. An end table was in front of the door just inside the bedroom. On top of this table and in plain view were a blue dinner plate with white residue on it, a pair of scissors with residue on the tips, burnt chore boy, and a flip cell phone. On the east wall of the bedroom was a dresser. There was a several inch gap between the dresser and the east wall. On the floor, behind the dresser, in plain view, were found 2 crack pipes with residue. As I passed by the front of the dresser I noticed the top drawer was partially open. Upon looking into the

drawer, I observed a crack pipe and chore boy. I opened the drawer and saw the listed metal tablespoon with white residue, two pill bottles with various pills inside, and 3 unfilled prescriptions.

No contraband was observed in plain view in the second bedroom.

In speaking with WALKER and MITCHELL, they stated that they are boyfriend and girlfriend. They stated that they rent the second bedroom from HARNESS, and that they do not frequent any other parts of the house besides their bedroom. It should be noted that in the second bedroom there is only enough space for 1 single bed, a dresser, a closet, and a table. They stated that they know HARNESS abuses drugs, but they do not. When asked about the items found in and on the coffee table, they stated that those belong to HARNESS and they are not allowed in the living room. Both WALKER and MITCHELL gave consent for officers to search their bedroom. No contraband was located in this room.

I next attempted to speak with HARNESS. He stated that he did not understand what was going on. I advised him that we were conducting an investigation regarding a counterfeit \$50.00 bill being passed at Burger King. HARNESS stated that he went to Burger King this morning with his friend "JOE" and JOE bought him a pop. I asked HARNESS why he tried to climb out the window and he did not answer. HARNESS refused to speak with me any further. I asked HARNESS for consent to search his bedroom, but he refused to answer. I was advised by P.O. LOWTHER that HARNESS was in possession of the listed folding blade knife while climbing out the window. In running HARNESS he showed to have 2 warrants. HARNESS has a warrant for PROBATION VIOLATION out of CCSO and a warrant out of the DEPARTMENT OF REHABILITATION AND CORRECTION/ADULT PAROLE AUTHORITY for PAROLE VIOLATION. The warrant with CCSO was confirmed by Dispatcher Kappa with Miller from CCSO.

It was learned, in speaking with all parties, that HARNESS uses the name "TONY" as an alias.

HARNESS was placed under arrest for OCCUPYING A DRUG PREMISES (513.14), CARRYING A CONCEALED WEAPON (549.02), DRUG PARAPHERNALIA (513.04), POSSESSION OF A HYPODERMIC (513.10), OBSTRUCTING OFFICIAL BUSINESS (525.07), and the warrants. WALKER was placed under arrest for OCCUPYING A DRUG PREMISES (513.14), DRUG PARAPHERNALIA (513.04), POSSESSION OF A HYPODERMIC (513.10), and OBSTRUCTING OFFICIAL BUSINESS (525.07). MITCHELL was placed under arrest for OCCUPYING A DRUG PREMISES (513.14), DRUG PARAPHERNALIA (513.14), and POSSESSION OF A HYPODERMIC (513.10).

P.O. LOWTHER and P.O. ZBYNOWSKI transport HARNESS to LPD where he was booked in by C.O. GONZALEZ and P.O. LOWTHER. P.O. REBRACA transported WALKER to LPD where he was booked in by C.O. GONZALEZ and P.O. REBRACA. P.O. WINTRICK transported MITCHELL to LPD where she was booked in by Dispatcher LEWANDOWSKI, C.O. GONZALEZ, and P.O. WINTRICK.

I confiscated, tagged, and transported all the listed property to LPD Property Room. I then contacted OIV/PAULA NICELY via telephone. NICELY is a pharmacist at Lakewood Hospital. The two listed pill bottles labels both stated that they contained 100 mg capsules of Doxycycline. However there were several different pills in each bottle. I described the pills and capsules to NICELY and she was able to tell me what they were. The first bottle contained 8 Doxycycline(100mg), an antibiotic, and 4 Suboxone (8mg/2mg), a schedule III drug. The second bottle contained 16 Doxycycline(100mg), 1/2 of a

Suboxone pill (8mg/2mg), and 24 Tramadol (50mg), a non-scheduled pain pill. I then spoke via telephone with OIV/THOMAS CRAIG III. CRAIG advised he has been seeing HARNESS as a patient for about 15 years. He stated that he did write the prescriptions found in HARNESS' apartment. He further added that he has prescribed Doxyxyline and Tramadol to HARNESS. However, he stated that he has never heard of Suboxone and does not recall ever prescribing it to HARNESS. HARNESS was subsequently charged with DRUG ABUSE (513.03).

The listed knife, chore boy, both cell phones, hypodermic needle, crack pipes, razor blade, plate, scissors, tablespoon, and pill bottles were confiscated, tagged, and secured in the drug chute of the LPD Property Room. The baggies of white powder with the razor blade was confiscated, weighed, tagged, and secured in the drug chute of the LPD Property Room.

HARNESS, WALKER, and MITCHELL all have CCHs. HARNESS has a BCI number of A701259 and an FBI number of 333964H. MITCHELL has a BCI number of B525341 and an FBI number of 836815XA8. WALKER has a BCI number of A780791 and an FBI number of 124888K3.
