<p>M.O.: By entering a vacant, single family home and stealing copper pipe and tools, without the owners knowledge or consent.</p> <p>On 4/7/08, at 1944 hrs, Inv. Deucher and I responded to 2059 Waterbury. Dispatch advised VIC/GAHSSAN STARKIS came home and found his house had been broken into, and he was unsure if anyone was still inside. Inv. Deucher and I cleared the house and found no one inside. The side door located on the south side of the house had been forced open. The frame was broken where the lock had been secured.</p> <p>Paneling along the east wall of the basement had been removed to expose copper pipe in the wall. The pipe in this wall, along the ceiling, and attached to the hot water tank, had been removed. The pipe along the ceiling had clean cuts, but those attached to the hot water tank were pinched and bent.</p> <p>In speaking with STARKIS I learned the following:</p> <p>STARKIS indicated he recently purchased the residence, and was just starting some repairs. STARKIS was at the residence at approximately 1100 hrs on 4/7/08, before he went to work, and the returned at approximately 2120 hrs. When he arrived at the residence, he put the key in the side door and found it unsecured. STARKIS contacted the police immediately.</p> <p>STARKIS indicated a sander, drill and hand saw were missing from the dining room. A 14" Pipe wrench and pair of pliers, originally in the dining room, were found in the basement. The ladder in the basement had been moved. New copper pipe and fittings, that STARKIS had purchased, were also stolen. This pipe was being stored upstairs in the north east bedroom.</p> <p>Inv. Deucher took photographs and processed the scene. Nothing of evidentiary value was located. I spoke with some of the surrounding neighbors. No one saw anyone coming or going from the residence, and did not see or hear anything suspicious.</p>
