| | MO; By passing a note to clerk that said this is a "Robbery give me the money." | |
| | <p>On 4-8-08, at 1730 hrs., I was at 14100 Detroit with PO PIECHOWIAK handling a detail when we overheard cars detailed to 11900 Detroit on the report of a Robbery in progress. We finished up and headed to 11900 Detroit to assist officers, SGT. SPAETZEL, SGT. FAVRE, INV. WALLING, INV. MALLOY, PO PIETCH, DET. MOTYLEWSKI and DET. MILLER, at the scene.</p> <p>On arrival, I was advised by SGT. FAVRE to handle the original report. I spoke with clerk, COM/JANIS HAWKINS, who said she works at the Courtesy desk in back of the store, next to the pharmacy. HAWKINS said a W/M, 20 to 30's years old, walked up to the first courtesy window and placed a drink on the counter. HAWKINS said the W/M mumbled something to her but she could not understand what he said. HAWKINS said this W/M started writing something on a scratch piece of paper left on the ledge of the outside courtesy window.</p> <p>HAWKINS said there was a B/M, 25 to 35 years old, that was behind the W/M in line. HAWKINS said she told the B/M to step over to the second window and she would help him. HAWKINS said the B/M pointed at the W/M in front of him that led her to believe he was with the W/M. then went back up to the first window. The W/M slid a note on the counter to her and she quickly read it. HAWKINS said the note basically said, this is a "Robbery and give me the money."

HAWKINS said she stepped back, dialed "911" on her cell phone and reached an operator. HAWKINS said she told the operator where she was and that she was being robbed. HAWKINS said she was transferred to LPD dispatch very quickly and she advised dispatch what was happening. HAWKINS said the W/M backed away from the window and walked away from the Courtesy desk area.

HAWKINS said the B/M then approached the Courtesy window. HAWKINS said the B/M asked her what the W/M had written and attempted to grab the note. HAWKINS said she pulled the note back on the counter and the B/M walked away from the Courtesy window. Note, the Courtesy window is raised from the ground floor of the patrons and there is a top shield above the Courtesy counter. This allows limited access to the desk portion of the countertop.

HAWKINS said shortly thereafter, INV. WALLING, DET. MILLER and DET. MOTYLEWSKI were on the scene. See their reports for further details.

HAWKINS thinks she would be able to identify the suspects if she saw them again. HAWKINS said the store will prosecute in this matter.

INV. MILLER was able to obtain photo's of the suspects involved from the video camera at the Courtesy desk.

The area was checked for the suspects but neither was located.
