Topic Original Report

M.O.: By removing the screen on the screen door, and unlocking the same, in an attempt to enter the residence.

On 4/8/08, at 0011 hrs, Officer Leanza and I responded to 1483 Lakewood regarding three males that had attempted to enter the residence. Dispatch advised the males were black or hispanic, wearing dark clothing, and were last seen running northbound on Lakewood. One male had unlocked the screen door by removing the screen. While doing so, the owner's dog bit him on the arm. There was approximately a ten minute delay in the call.

When I arrived on scene I spoke with VIC/GREGORY GRUSZKA and learned the following:

GRUSZKA indicated the front door to his residence was open, but the screen door was locked. He was upstairs with his wife, son and dog. GRUSZKA stated his dog began to bark and ran down the steps. As GRUSZKA followed, he observed a male reaching through his screen door unlocking the same. It was at this time his dog bit down on this male's left arm. GRUSZKA heard a male yelling "let go" several times, while two others were yelling to get out of there. GRUSZKA stated there were three males. All of which were light skinned. GRUSKA stated he was unsure if they were black or hispanic, but believes they may have been hispanic based on their accent. GRUSKA stated after the dog let go of the males arm, he ran out of the door after the males southbound on Lakewood. After chasing them for a few moments he returned home and contacted the police.

When we arrived on scene, the screen door was bent and lying on the front porch in front of the door. GRUSKA stated the screen was still partially in the door when the dog bit the male, but fell out completely when he ran out after them.

GRUSKA stated he did not recognize the males, and he desires prosecution. Inv. Deucher took photos and processed the scene. Nothing of evidentiary value was located. As of 0500 hrs on 4/8/08, no one came to the Lakewood ER with a dog bite injury.
