Topic Original Report

M.O. - By having in his possession, a controlled substance, To Wit: Having .39 grams of crack cocaine in his front left pocket.

M.O. - By having in his possession, a ceramic crack pipe with chore boy and burnt residue, used to smoke crack cocaine.

M.O. - By punching victim with a closed fist in the face causing physical injury.

On 4-11-08, at approximately 0229 hrs, officers were detailed to the Shamrock Tavern at 11922 Madison on the report of three males beating up another male. Prior to officers arriving, dispatch advised that a gun may possibly have been involved and one of the males involved went back in the side door of the Shamrock Tavern.

Upon arrival, I found a male, later identified as VIC/ DOUGLAS RIGNEY, lying on the sidewalk in front of the bar. He was bleeding from the left side of his face. At that time, COM/ MICHAEL AYBAR, who is the manager of the Shamrock, stated that the male who had assaulted RIGNEY ran E/B on Madison. AYBAR stated that the suspect in the assault was a black male in his 30's or 40's, approximately 5'6, average build, wearing a blue jacket. Other officers began checking the area for the suspect at that time. AYBAR also stated that there were no other parties involved and no weapons were observed.

Squad 3 arrived on scene and transported RIGNEY to the ER.

According to AYBAR, RIGNEY had been in the bar earlier in the evening but had left. AYBAR thought that RIGNEY had gone to the Flying Rib next door. A few hours later, RIGNEY returned to the Shamrock and went into the back patio area of the bar and sat by himself. AYBAR also stated that he observed the suspect, later identified as ARA/ DONALD PAULDO, enter the bar. A short time later, AYBAR advised the patrons of the bar it was closing time and asked everyone to leave. When RIGNEY left the bar, AYBAR observed PAULDO run out the door of the bar after RIGNEY. AYBAR immediately exited the bar as well, because he felt there was going to be a problem with the two males outside.

When AYBAR exited the east door of the bar, he observed PAULDO punch RIGNEY in the face with a closed fist. RIGNEY fell to the ground and PAULDO attempted to keep hitting RIGNEY, but AYBAR separated the males. At that time, PAULDO attempted to run back into the Flying Rib, but the front door was locked and he then left running E/B down Madison. AYBAR went back into the bar and contacted LPD and he did not see where PAULDO went.

When AYBAR came back outside to assist RIGNEY, he thought he saw PAULDO standing on the sidewalk approximately two blocks west of the Shamrock. AYBAR also stated he would be able to identify the male again if he saw him.

A few minutes later, Sgt. Kauchek and Ptl. Hayes observed a male, matching the description AYBAR had provided, riding a bike S/B on Ridgewood near Madison. They approached the male, identified him as PAULDO, and spoke with him about the situation. PAULDO denied being involved in any fight near the Shamrock.

Inv. Fioritto drove AYBAR to Ptl. Hayes and Sgt. Kauchek's location and AYBAR positively identified

PAULDO as the male who had assaulted RIGNEY.

At that time, Inv. Fioritto and I responded to the ER to speak with RIGNEY. RIGNEY was highly intoxicated and was unable to tell us what had happened. RIGNEY kept saying that he was fine and he did not know what happened. The only visible injuries he had at that time were some swelling and redness to the left side of his face and a couple of abrasions, also on the left side of his face.

Inv. Fioritto took photos of RIGNEY's injuries.

RIGNEY was treated by Dr. Gabrin for his injuries. It was later learned that RIGNEY also had a fractured left ankle. Due to RIGNEY's intoxicated state, however, he was unable to tell us whether or not it was a result of the assault.

After being advised that he had been assaulted, RIGNEY stated he did desire prosecution.
