Topic Original Report

On 4-12-08, at 0417 hours, units were detailed to the area of 13389 Madison on a report of fighting and glass breaking. On arrival no one was found in the area. WIT/SIDELKA spoke to PO Gampfer. She said she observed two parties jump off a balcony at 13395 Madison. She stated they were in their underwear and "running for their life". The two were screaming for someone to call the police. SIDELKA pointed out 13395 Madison #102 as the balcony they came off of.

In checking 13395 Madison #102, we found OIV/JOY BEARER. JOY stated that the apartment she was in belonged to her daughter, VIC/HEIDI BEARER and her boyfriend, VIC/JOHN JELENTIC. She was sleeping on the couch when she heard pounding at the door. JOHN opened the door and a male she knows as SHOWBIZ came inside.

She stated SHOWBIZ started throwing HEIDI and JOHN around the apartment and into the walls. He was knocking over furniture. He was screaming about getting his money. He grabbed the dog and threatened to hurt the dog. HEIDI and JOHN ran out on the balcony and jumped off. SHOWBIZ broke out a bedroom window and the sliding glass door on the balcony. He left the apartment, saying something about coming back and shooting the place up.

JOY stated SHOWBIZ did not threaten her. He told her to stay out of his way. I asked JOY if this was a drug related incident. She replied, "possibly". She did not know where HEIDI or JOHN might have went. Units checked the area for HEIDI, JOHN and SHOWBIZ with negative results.

JOY stated SHOWBIZ was last know to have a dark blue Lincoln with a temp tag. She thought he lived at the apartments at Chesterland/Madison. PO Leanza and PO Molnar checked the apartments in the area with negative results.

INV MLADEK responded and took photos of the apartment. The apartment opened up into the living room. The coffee tables and chairs in this room were turned over. The balcony window was shattered. The kitchen comes off the living room to the South. A lamp was shattered on the floor. to the SW of the kitchen was the bedroom where the window was shattered.

JOY provided the spelling for JELENTIC's last name. I was unable to locate any information on him in the computer.
